RFD*Internal

Used by Regional Permitting Staff to

- Review application for determination
- Reject incomplete applications
- Render a determination



Design Features

- Approver assigns RFD to a Reviewer
- Approver approves the final determination rendered by a Reviewer.
- Reviewer can flag questionable data items and reject application.
- Note system for communication
- Easily saved or printed final
 Determination in PDF format



Stages of RFD Application





Error Icons

- "Request Verification" appears for all editable data elements in an RFD.
- "Verify" is used by the reviewer to indicate a potential problem.
- "Acknowledged" replaces "Verify" when issue is addressed by the user.
- "Modified" identifies changes made by the user that were not requested by the Reviewer.



Approve/Deny

- Checks for completeness.
- Produces PDF summary of Determination.
- Notifies Internal and External users of determination.
