#### ANNOUNCEMENTS

- Electrify America is seeking comments for Cycle III investments (Jan 2022 – Jun 2024)
  - Comments Due July 31
  - https://www.electrifyamerica.com/submissions/
- DC Fast Charging and Hydrogen Fueling Grant Program opened on July 2<sup>nd</sup>
  - Up to \$1,800,000 in funding available
  - Application deadlines of 9/4/2020 and 2/26/2021
  - Up to 70% or \$250,000 per project for DC fast charging
  - Up to 33% or \$500,000 per project for hydrogen fueling



### ANNOUNCEMENTS

- On July 14<sup>th</sup>, Pennsylvania joined 14 other states and DC in signing the Medium and Heavy-Duty ZEV Memorandum of Understanding through NESCAUM
  - Commitment that 30% of new medium and heavy-duty be ZEV by 2030
  - 100% of new medium and heavy-duty be ZEV by 2050



- Legislative Updates

### **HIGHWAY RE-AUTHORIZATION**

- House version INVEST Act
  - \$8.35 billion over five years to reduce greenhouse emissions from transportation
    - Over \$30 million per year to PA
  - \$1.75 billion over five years to Alt Fuel Corridor infrastructure
    - Competitive grant program
  - Five-fold increase in electric transit bus funding

- Senate version
  - \$3 billion over five years to reduce greenhouse emissions from highways
    - Over \$12 million per year to PA
  - \$1 billion over five years to alternative fueling infrastructure
    - Competitive grant program
