Hazardous Sites Cleanup Project Activities and Expenditures, FY 2020-21

This appendix lists the estimated expenditures (not including DEP personnel and general operating costs) and the type of response activity performed for each project funded by DEP using the Hazardous Sites Cleanup Fund in the fiscal year July 1, 2020– June 30, 2021. The estimated expenditures include the actual expenditures existing as of July 1, 2021, and an estimate of the obligation remaining to be paid under existing contracts for work completed, but not invoiced, audited and expended as of July 1, 2021. The description of the type of response activity performed includes whether the activity was initiated, completed or was continuing from prior fiscal years.

During FY 2020-21, DEP initiated two and completed three response actions. Including other response actions that continued from previous years, total project expenditures under the Hazardous Sites Cleanup appropriation for FY 2020-21 are estimated at \$11 million.

In FY 2020-21, there were no contract expenditures for intervention and environmental mediation services; no contract expenditures for rehabilitation, restoration or acquisition of natural resources; no health effect studies undertaken, and no reimbursements of expenses under section 505(f) of HSCA.

The total contract cost in FY 2020-21 for temporary water supply maintenance at these sites is estimated to be \$159,000.
