requirements of Act 2 and the regulations published in Chapter 250 of the PA Code.

The manual provides suggestions and examples of how to best approach site

characterization, remediation and demonstration of attainment.

APPLICABILITY: The guidance in this manual is applicable to any person or persons conducting a site

remediation under Act 2 and who wish to receive the liability protection afforded by

Chapter 501 of that act.

DISCLAIMER: The policies and procedures outlined in this guidance document are intended to

supplement existing requirements. Nothing in the policies or procedures will affect

regulatory requirements.

The policies and procedures herein are not an adjudication or a regulation. There is no intent on the part of the Department to give these rules that weight or deference. This document establishes the framework, within which DEP will exercise its administrative discretion in the future. DEP reserves the discretion to deviate from

this policy statement if circumstances warrant.
