

# Public Uploads for active mining operations and mining programs

Public Upload with Payment is available to submit digital versions of applications and forms and pay the fee, if applicable, via credit card or Telecheck. If there is no epermitting option, clients and applicants are encouraged to use the Public Upload with Payment tool to submit. The following guide provides directions on Public Upload submittals and answers some specific questions to make the process efficient and minimize processing errors.

**Before submittal**: Have digital versions of the completed documentation in PDF or XLS format. Have payment information available for entry. Unless you have made direct arrangements with the permitting DMO for paying the fee via paper check, **do not submit an application without the required fee**.

**Resubmittal**: The first screen asks if this is a resubmittal. This only applies if you have previously applied through Public Upload and have an access code for this submittal. If you have not previously used Public Upload, answer NO. If you have already submitted an application via paper or through the previous OnBase system, do not use this resubmittal. Select NO and upload the additional material, but choose "exempt" for the fee question if the fee was already paid. Note this in the comments.

**Submission Type Filter**: Mining and explosives-related submittals may be routed to one of two Bureaus. Please note the differences outlined below and chose the appropriate Bureau (DMO or MP). Failure to identify and route the form correctly may result in rejection.

#### **DISTRICT MINING OPERATIONS DMO**

 All permit activity, blast plans, bond revisions, certification, self-monitoring and reporting by permit, civil penalty payments, financial guarantee payments, stream restoration reports, extra documentation.

#### **MINING PROGRAMS MP**

 Mining license applications, mine production reporting, coal ash beneficial use certification and source reporting, blasters and explosive storage licenses, epermitting and eDMR security forms, UFM and Good Samaritan projects.

**Filter Submission Types by Program:** This dropdown menu selects the submission type. The types are limited based on the filter selected above (DMO or MP). Your choice determines if a fee will show up as required.

**Request Type**: Choose the best response for your submittal - New, amendment (major or minor). Your choice determines if a set or variable fee will be required. Note that if a submittal type does not have an associated fee, the fee box will not appear.

**Permit #**: Enter the mining permit number, NPDES permit number, license number, certification number, or other specific ID as appropriate.

**Applicant EIN:** Not required.

Project Address: Use the official company address,

**County/Municipality/Region**: For any individual submittal, use the county of residence. For an application related to a facility, use the facility's main county. This field determines which **surface** 

District Mining Office applies. Note that some submittals will be correctly directed to the Bureau of Mining Programs or to the California District Mining Office even though the listing shows otherwise.

**Submission Notes:** Please add a brief description of what is included and any additional information about the fee submittal process. If the project should be directed to the California DMO, please note it here. Clear details included here helps to efficiently process the submittal.

It is also recommended by California DMO that you email <u>RA-EPCALIFORNIAMO@pa.gov</u> to confirm that an application is received by that office.
