ANTHRACITE OPERATORS

Anthracite Blasting Competency Certification (shot firer) training sessions will be provided to accommodate underground mine personnel in complying with requirements for verification of blasting competency prior to obtaining a miner's certificate. All persons applying for a certificate of competency, or to entitle them to be employed as miners, must produce satisfactory evidence of having had <u>no less than</u> two years' practical experience as a mine laborer in the mines of the Commonwealth. Fall session scheduled for February 24th and March 3rd 2016.

Training is scheduled 4:00 p.m. to 9:00 p.m. at the Tremont Mine Rescue Station, 44 North Crescent Street, Tremont, PA. The two-day training session will consist of gas detection and blasting awareness training on the first day and a written and hands-on test will be administered on the second day. All applicants are required to attend the two-day certification session.

A copy of the application is enclosed for your convenience. Please have the application *COMPLETED*, *NOTARIZED* and return to DEP, Bureau of Mine Safety, 5 West Laurel Boulevard, Pottsville, PA 17901 as soon as possible but no later than **February 19th**. The application will be reviewed for eligibility to qualify for the examination <u>before</u> attending the training. Please be sure to use the updated application (revision date 8/2010). If you require additional copies and are unable to make copies, please contact this office, Scott Wolfgang or your State Mine Inspector for additional applications.

Pre-registration is requested due to the class size limit of 10. Please contact this office or Scott Wolfgang at 570-695-3610 to register for the training session that will best fit your schedule.
