

THE STATE CIVIL SERVICE COMMISSION IS CURRENTLY ACCEPTING APPLICATIONS FOR THE [MINING ENGINEER TRAINEE/MINING ENGINEER SPECIALIST](#) JOB TITLES.

MINIMUM EXPERIENCE/TRAINING REQUIRED: Applicants for Mining Engineer Trainee must possess a bachelor's degree in mining engineering; or one year of mining engineering experience, and possession of a valid Engineer-in-Training certificate issued by or acceptable to the Pennsylvania State Registration Board for Professional Engineers, Land Surveyors and Geologists.

In order to qualify for the Mining Engineering Specialist, applicants must possess one year of professional experience in mining engineering, and a bachelor's degree in mining engineering; or two years of professional experience in mining engineering, and possession of a valid Engineering Training certificate issued by or acceptable to the Pennsylvania State Registration Board for Professional Engineers, Land Surveyors and Geologists; or one year of professional experience in mining engineering and possession of a valid Professional Engineer license issued by the Pennsylvania State Registration Board for Professional Engineers, Land Surveyors and Geologists. Graduate study in mining engineering may be substituted for the required experience on a year-for-year basis.

CONDITION OF EMPLOYMENT: Possession of a valid Pennsylvania driver's license. Applicant must be a Pennsylvania resident.

DUTIES: Providing technical and engineering support within the Bureau of Mine Safety to ensure its operations are conducted efficiently and effectively, with the goal of ensuring the safety of underground miners and the public.

LOCATION: Vacancy in Fayette County (Uniontown).

WORK SCHEDULE/SALARY: This position will work a 40-hour workweek and be on call 24 hours a day. The starting salary is for Mining Engineering Trainee is \$52,849 and Mining Engineering Specialist is \$55,185.
