
Dear Mr. Shultz:

We have completed our evaluation of the equipment noted above, and approve its use in all bituminous underground coal mines of Pennsylvania. The equipment meets the legal requirements of the *Pennsylvania Bituminous Coal Mine Act*.

Pennsylvania approval number BOTE-D 0032-06 has been assigned to the equipment. This number must appear conspicuously on the outside of the subject equipment on a 2" x 4" rust-resistant metal plate, or any other Bureau acceptable material. The approval plate should read "Commonwealth of Pennsylvania" and "Approval No. BOTE-D 0032-06." The plate and lettering should be resistant to removal by abrasion.

The minimum ventilating air quantity for this specific piece of diesel-powered equipment is 6000 cfm. This approval number and ventilation rate must be stamped on an approval plate that must be attached to the diesel powered engine and emission system.


