
Dear Mr. Schmader:

We have completed our evaluation of the equipment noted above, and approve its use in all bituminous underground coal mines of Pennsylvania that do not utilize a DC powered trolley system. Prior to being used in mines containing trolley wire, additional safety requirements must be provided and approved by the Bureau. The equipment meets the legal requirements of the *Pennsylvania Bituminous Coal Mine Act*.

Pennsylvania approval number BOTE-D 1907-02 has been assigned to the equipment. This number must appear conspicuously on the outside of the subject equipment on a 2" x 4" rust-resistant metal plate. The approval plate should read "Commonwealth of Pennsylvania" and "Approval No. BOTE-D 1907-02." The plate and lettering should be resistant to removal by abrasion.
