Dear Mr. Lovern:

This letter is to clarify the approval granted by the Department for the above-referenced diesel fuel transportation unit. The unit, as approved, is equipped with rubber tires, and is only approved for transportation of fuel on rubber tires in rubber tire haulageways. The unit, as approved, does not meet the requirements of the Pennsylvania Bituminous Coal Mine Act for transportation of fuel in track-trolley haulageways. Use of this unit for transportation of diesel fuel in track-trolley haulageways will result in a violation of the Department's approval.

In order to comply with the Pennsylvania Bituminous Coal Mine Act and obtain approval for duel use in rubber-tired and track-trolley haulageways, the following would be needed:

1. Convert the rubber-tired wheels to a dual use rubber/rail wheel.

2. Cover the top of the unit with an insulating material to protect the unit from energized trolley wire.

If you elect to modify the current approval for this unit, please submit a revised drawing and application to the Bureau for approval.
