Transcontinental Gas Pipe Line Company, LLC (Transco) is submitting electronic copies of updates to the Federal Energy Regulatory Commission (FERC) Well Monitoring Plan (Plan) as supplemental information to the Columbia, Lancaster, Lebanon, Luzerne, Northumberland, Schuylkill, Susquehanna, and Wyoming County Chapter 105 Water Obstruction and Encroachment Joint Permit Applications (Applications) for the Atlantic Sunrise Project (Project).

Transco submitted a previous version of the Plan to FERC in February 2017 to satisfy a condition of the FERC Certificate of Public Convenience and Necessity. The enclosed version of the Plan includes the following revisions, and will be provided to FERC with the submission of the Notice to Proceed Request:

- The expansion of the well monitoring area from 150 feet of edge of the Project workspace to 450 feet from the horizontal directional drill (HDD) alignments;
- Offering pre-, during and post-construction sampling for wells within the HDD well monitoring corridor; and

• Updated parameters list consistent with the PADEP Recommended Basic Oil and Gas pre-Drill Parameters (PADEP 2016).
