Transcontinental Gas Pipe Line Company, LLC (Transco) is submitting the following revised Application in response to the Technical Deficiency letter issued by the Pennsylvania Department of Environmental Protection (PADEP) Southcentral Regional Office on February 24, 2017 for the Chapter 105 Water Obstruction and Encroachment Joint Permit Application (Application). The original Application for the portion of the Atlantic Sunrise Project (Project) located within Lancaster County was submitted to the PADEP on August 28, 2015, with a revised version of the Application submitted on November 22, 2016 as response to technical deficiency comments. Transco requested an extension to respond to the technical deficiencies issued on February 24, 2017, which was granted by the PADEP on April 26, 2017.

Per the PADEP's request, with this transmittal we are providing all portions of the original Application with the Project revisions due to new survey data and response to technical deficiencies.
