#### **Dear Governor Corbett:**

The Citizens Advisory Council (Council, CAC) to the Pennsylvania Department of Environmental Protection (DEP) is pleased to submit its 2010 Annual Report for your review. As you know, Act 275 of 1971 established the Council, mandating among other things that the Council perform non-partisan, independent oversight of the operations, management and policy of the Department of Environmental Protection. We provide advice concerning environmental matters to DEP, the Governor, the General Assembly, and the Commonwealth's federal representatives.<sup>1</sup>

Council members are a diverse group of citizen appointees from across Pennsylvania, who spend a substantial amount of their time in assisting and advising the DEP. In addition to attending monthly Council meetings and actively participating in committee-related responsibilities, many members also serve on program specific advisory committees and boards. Council annually elects five voting members on the Environmental Quality Board, as well.

In 2010, much of our time and effort focused on the pending transition in administrations, how to respond to the impacts of repeated budget and resource reductions on the department, and issues related to development of the Marcellus Shale.

• The first phase of our transition effort, *Key Environmental Issues for the Keystone State*, identified four major areas of critical concern to Pennsylvania's present and future environment: Environmental Protection and Community Health; Environmental funding; Energy Resources and Development; and Climate Change. The report was distributed to all gubernatorial candidates in early 2010, with the intent of focusing public dialog on these issues and recommendations.

- The second phase of our effort, *Protecting Pennsylvania's Environment: Issues for a Challenging Time*, is a more detailed set of operational recommendations for the governor-elect and secretary-designee to consider for the official transition to a new administration. It focuses on operational and management issues related to DEP, providing the CAC's collective thinking on how to revive and sustain the agency's role and capability to protect the Commonwealth's environmental, community and economic health.
- CAC and CNRAC, our DCNR counterpart, continued to jointly address issues related to
  development of Marcellus Shale, including several education sessions and a regional business
  trip to investigate Marcellus Shale natural gas development activities and concerns in and around
  Sproul State Forest. This was the second consecutive year that both councils jointly met with
  representatives of the natural gas industry, state forest managers, and representatives of the
  communities being impacted by this broad industrial development activity.

These highlighted activities, in addition to many others, are discussed in the attached report on the 2010 activities, positions and recommendations of the CAC.

Council continues to welcome open communication with you, the Pennsylvania General Assembly, and the citizens of the Commonwealth with regard to issues of environmental concern to Pennsylvania. Council takes its mandate very seriously and encourages the citizens of the Commonwealth to be actively engaged in the protection of their air, soil and water.

# CITIZENS ADVISORY COUNCIL TO THE DEPARTMENT OF ENVIRONMENTAL PROTECTION

# **COUNCIL OVERVIEW**

Since its creation in 1971, the Citizens Advisory Council (Council, CAC) has been actively involved in environmental issues affecting the Commonwealth. The objective for creating the Council in 1971<sup>2</sup> was to establish a non-partisan body to represent citizen viewpoints and provide objective analyses of the Department of Environmental Protection's (DEP) performance and environmental issues in general. This legislation gave the Council three specific charges:

- (a) The Citizens Advisory Council shall review all environmental laws of the Commonwealth and make appropriate suggestions for the revision, modification, and codification thereof.
- (b) The Council shall consider, study, and review the work of the Department of Environmental Protection and for this purpose, the Council shall have access to all books, papers, documents, and records pertaining to or belonging to the Department.
- (c) The Council shall advise the Department on request, and shall make recommendations upon its initiative, for the improvement of the work of the Department.

Council is the only legislatively mandated advisory committee with the comprehensive charge to review all environmental legislation, regulations, and policies affecting the Department of Environmental Protection. In addition, the 1992 amendments to Pennsylvania's Air Pollution Control Act require DEP to consult with Council in developing state plans and regulations to implement the federal Clean Air Act. To carry out these responsibilities, Council by law<sup>3</sup> is granted access to all DEP records. Council reports annually to the Governor, the General Assembly, DEP and the public.

Council has 19 members: 18 appointed citizen volunteers and the Secretary of the Department of Environmental Protection. The Governor, the Speaker of the House of Representatives, and the President Pro Tempore of the Senate each appoint six members, with no more than half from the same political party. Because the appointments originate from different authorities, Council's membership is geographically, politically and professionally diverse. Appointees must be familiar with the work of DEP and willing to commit the time and energy required. Members serve staggered 3-year terms and may serve until successors are appointed.

Council typically meets monthly, except August and December, and at the call of the chairperson. Meetings are open to the public and advertised as required by the Sunshine Act.<sup>4</sup>

Each year, Council holds a regional meeting in a different part of Pennsylvania to gather input about environmental activities and concerns in that area. In 2010, Council again held several sessions in conjunction with the Conservation and Natural Resources Advisory Council (CNRAC), including a joint regional meeting in September.

Council elects five members annually to serve as the only citizen representatives to the Environmental Quality Board (EQB), a 20-member independent board that adopts all of DEP's regulations.<sup>5</sup> In 2010, the EQB convened 10 times to consider 3 petitions, one petition withdrawal, 12 proposed and 22 final rulemakings.

Council elects 4 members to serve on the Mining and Reclamation Advisory Board.<sup>6</sup> Council also holds seats on the Air Quality Technical Advisory Committee; Low-Level Radioactive Waste Advisory Committee; Radiation Protection Advisory Committee; and Solid Waste Advisory Committee.

Council is also represented on the Environmental Hearing Board Rules Committee<sup>7</sup> and the Oil and Gas Technical Advisory Board.<sup>8</sup>

Council is granted the independence to hire its own staff by law. Due to the layoffs in 2009, in 2010 staff included Susan M. Wilson, Executive Director, with support provided by Ms. Toni Muhammad in the Office of Communications, and Ms. Tammey Adams in the Secretary's Office. The Council's offices are located on the 13th floor of the Rachel Carson State Office Building in Harrisburg.

# 2010 PRIORITIES

Much of our time and effort over the course of 2010 focused on the pending transition to a new administration, how to respond to the impacts of repeated budget and resource reductions on the agency, and issues related to development of the Marcellus Shale; these issues are highlighted in the following report on the activities, positions and recommendations of the Citizens Advisory Council, pursuant to its mandates, from January 1 - December 31, 2010.

#### **TRANSITION**

Council's Strategic Planning Workgroup formally began working on transition issues in early 2009. After numerous conference calls, workgroup meetings and full Council deliberations, Council approved the first phase of its transition effort, *Key Environmental Issues for the Keystone State: A Transition Statement Regarding the Department of Environmental Protection* on January 19, 2010.

Key Environmental Issues for the Keystone State identified four major areas that Council felt were of critical concern to Pennsylvania's present and future environment: Environmental Protection and Community Health; Environmental Funding; Energy Resources and Development; and Climate Change. The report identified recommendations to address these challenges in innovative and holistic ways, that augment traditional tools and concepts.

Key Environmental Issues for the Keystone State was distributed to all gubernatorial candidates in early 2010, with the intent of focusing public dialog on these issues and ensuring that they were addressed in the candidates' political platforms. On April 20, 2010 representatives from both CAC and CNRAC, were invited to meet with Attorney General Corbett's campaign staff to discuss key issues.

Once this first phase was in play, Council continued to pursue the second stage of the transition effort, a more detailed set of operational recommendations for the governor-elect and secretary-designee to consider for the official transition to a new administration. Again, after numerous conference calls, budget reports and discussions with the department and workgroup and full Council meetings, on October 19, 2010 Council approved *Protecting Pennsylvania's Environment: Issues for a Challenging Time*. This report focuses on operational and management issues related to DEP, providing the CAC's collective thinking on how to revive and sustain the agency's role and capability to protect the Commonwealth's environmental, community and economic health.

Issues for a Challenging Time was sent to Governor-elect Corbett on November 3, 2010, along with a request for an opportunity to meet with his transition team to discuss operational and management issues and recommendations. On December 8, Council's Executive Director was invited to meet with representatives of the Energy and Environment Committee of the Transition Team, to discuss the issues identified in our reports.

#### **BUDGET ISSUES**

As noted above, Council held numerous discussions with the department regarding budget and resources issues, including monthly reports from DEP's Deputy Secretary for Administration, Patrick McDonnell. Budget and funding data were evaluated, with discussions focused on the Department's workload and resource shortfalls in its various programs and regions. These dialogs formed the basis for the transition discussion. In addition, on receiving news that further cuts to environmental funds were under consideration, Council issued a June 24, 2010 *Statement of Concern Regarding further Cutting of Environmental Funds* to members of the General Assembly.

#### **MARCELLUS ISSUES**



As part of the joint effort to encourage coordination between Pennsylvania's two sister natural resource agencies, CAC and CNRAC continued to jointly address issues related to development of Marcellus Shale. In addition to discussions at virtually every Council meeting, on January 19, 2010, the Councils held a joint educational forum on severance taxes. Invited presenters included:

- Michael Wood, Research Director of the Pennsylvania Budget and Policy Center
- Mark Morton, Director of the West Virginia Tax Department's Legal Division
- Dan Hassell, Acting Secretary, Pennsylvania Department of Revenue

In March, both councils approved the *Joint North Central Regional Business Trip Report*. This field trip focused on two areas of mutual interest—Marcellus Shale development, and Abandoned Mine Drainage (AMD) issues on state forest lands.



In June, DEP's Bureau of Air Quality gave presentations on air quality issues applicable to Marcellus Shale gas extraction activities, and on the Marcellus Shale air sampling project, a sampling protocol for emissions such as VOC, CO and NOx.

In July, CAC and CNRAC convened another joint session to continue to discuss issues of common concern. Invited speakers for this session included:

- Carl Carlson, Director of Government Affairs, Range Resources, and Bruce Snyder, Senior Environmental Resource Specialist, Range Resources, regarding the company's drilling activities and concerns
- Andrew Heath, Executive Director of Renew Growing Greener
- Scott Perry, Director, Bureau of Oil and Gas Management, re: Marcellus emergencies.

In September, the two councils held another joint regional field trip, to investigate Marcellus Shale natural gas development activities and concerns in and around Sproul State Forest. This is the second consecutive year that both councils jointly met with representatives of the natural gas industry, state forest managers, and representatives of the communities being impacted by this broad industrial development activity. In November, both councils approved the report on this trip, the *Joint Northcentral Regional Business Trip Report, September 21-22, 2010.* 

# COMMITTEE AND WORKGROUP ACTIVITIES

# AIR COMMITTEE

Pennsylvania's air quality has continued to improve and considerable progress has been made. However, the Commonwealth continues to face new challenges. At times, these challenges require innovative, aggressive action to protect Pennsylvania citizens and the environment. The department must be poised to identify these challenges and be prepared to utilize creative solutions to meet the demands of Pennsylvania's ever-changing air pollution issues.

## **Rulemakings**

The Air committee held a number of meetings and conference calls to consider rulemaking packages being developed by the Bureau of Air Quality. On the committee's recommendation, Council approved the following:

- Concurrence letter: final Adhesives, Sealants and Primers rulemaking, and Glass Melting Furnaces rulemaking (1/19/2010)
- Concurrence letter: proposed Sulfur Limits in Fuel Oil rulemaking (3/16/2010)
- Letter to Joyce Epps regarding the need to be sure that the Outdoor Woodburner regulations are protective of public health (4/20/2010)
- Comment letter regarding final Outdoor Woodburner rulemaking (6/15/2010)
- Concurrence letter: final control technique guidelines for Flatwood, Panelling rulemaking, and final Paper Film and Foil rulemaking (7/28/2010)
- Concurrence letter: final New Source Review for Fine Particulates rulemaking, and Final Fees for Title V rulemaking (10/21/2010)

In addition, on December 7, 2010, the committee sent a concurrence letter regarding the proposed High Electric Demand Days rulemaking. The committee's recommendation will be discussed at the January 2011 meeting.

#### Miscellaneous

On February 16, 2010, the Office of Energy and Technical Deployment provided an update on the Climate Change Action Plan of 2009, which includes specific recommendations for mitigation of greenhouse gases to lower the CO2 that is emitted.

At the June meeting, the Bureau of Air Quality gave presentations on air quality issues applicable to Marcellus Shale gas extraction activities, and on the Marcellus Shale air sampling project, a sampling protocol for emissions such as VOC, CO and NOx.

#### ENVIRONMENTAL STANDARDS COMMITTEE

The Environmental Standards Committee primarily handles regulatory and policy issues for mineral resources, waste, land recycling, and energy.

Section 18.1 of the Bituminous Mine Subsidence and Land Conservation Act requires DEP to report its findings regarding the effects of underground mining on overlying land, structures, and water resources to the Governor, General Assembly and Citizens Advisory Council at five-year intervals. Status reports on the pending Act 54 report were provided throughout the year. This report will address underground mining impacts for the period August 2003 to August 2008, and is being developed by the University of Pittsburgh under the leadership of a professor who formerly worked for both the National Institute for Occupational Safety and Health (NIOSH) and the Bureau of Mines. The final report is expected before the end of 2010.

At the June meeting, Todd Wallace, Acting Director of the Bureau of Waste Management provided an overview of the final coal ash regulations moving through the rulemaking process. He stated that Pennsylvania has a model program, and plans to move forward with the regulations even though EPA is considering two different approaches to the regulation of coal ash.

At the October meeting, Deputy Secretary for Mineral Resources Scott Roberts reported on the EPA Conductivity Benchmark and its potential impacts on mining and how Pennsylvania deals with abandoned mines and mine drainage. There is concern that EPA's directive will create many problems for Pennsylvania mine sites, new and old, as well as with remining efforts. Using this standard could adversely impact our abandoned mine drainage projects, particularly in light of other activities that suggest that we should be requiring NPDES permits for watershed groups constructing AMD passive treatment systems.

#### WATER COMMITTEE

The Water Committee held several conference calls and committee meetings to discuss regulatory packages and water issue updates.

- April 27, 2010 call with Deputy Secretary for Water Management John Hines and Bureau of Water Standards and Facility Regulation Director Dana Aunkst to review 4 regulatory packages:
  - o Chapter 92a—National Pollutant Discharge Elimination System (NPDES) fees
  - o Chapter 96—codifying Pennsylvania's nutrient trading initiative
  - o Chapter 95—wastewater treatment/total dissolved solids (TDS)

- o Chapter 102—Erosion and Sedimentation (E&S)/buffers
- October 19, 2010 committee meeting regarding watershed implementation plans and the Chesapeake Bay Total Maximum Daily Load (TMDL) being imposed by EPA.
- Also at the October council meeting, Deputy Secretary for Mineral Resources Scott Roberts reported on the EPA Conductivity Benchmark and its potential impacts on mining and how Pennsylvania deals with abandoned mines and mine drainage. There is concern that EPA's directive will create many problems for Pennsylvania mine sites, new and old, as well as with remining efforts. Using this standard could adversely impact abandoned mine drainage projects, particularly in light of other activities that suggest that we should be requiring NPDES permits on watershed groups.

#### STRATEGIC PLANNING WORK GROUP

As noted previously, Council's Strategic Planning Workgroup formally began working on transition issues in early 2009. The workgroup facilitated Council's effort throughout 2009 and into 2010, as outlined on page 3.

# COUNCIL NEWS/UPDATES

*Elections* – In January, Peter Wilshusen was elected to fill the remainder of Bernie Hoffnar's term on the Environmental Quality Board (EQB).

In February Walter Heine indicated that he did not wish to seek reelection to the Mining and Reclamation Advisory Board (MRAB). Walter was recognized for his many years of service and leadership on MRAB. Eric Conrad and Curtis Kratz were elected to serve two-year terms on the MRAB, replacing Walter Heine and Bernie Hoffnar. Mark Killar of the Western Pennsylvania Conservancy (WRC) was elected to serve as a second alternate to the MRAB.

Council leadership and Envirionmental Quality Board (EQB) elections were held in July. The results of the leadership elections were: Joyce Hatala, chair, and John Walliser, vice chair. The following individuals were re-elected to represent Council on the EQB: Jolene Chinchilli, Walter Heine, Richard Manfredi, David Strong and Peter Wilshusen. Council's EQB alternates are Cynthia Carrow, Gail Conner, Pat Lupo, and John Walliser.

Committees – In April, Burt Waite resigned as chair of the Water Committee, and Thad Stevens was appointed to the position. Eric Conrad was appointed as chair of the Administrative Oversight Committee. John Walliser was appointed to represent the CAC on the Air Quality Technical Advisory Committee. In July, Council created the Prospective and Strategic Projects committee to replace the Strategic Planning Workgroup and the Integrated Projects committee, to be chaired by Jolene Chinchilli.

# LEGISLATIVE MANDATE

#### ACT 275 OF 1971

#### Section 448. Advisory Boards and Commissions

(p) The Citizens Advisory Council shall consist of the Secretary of Environmental Protection, six members who shall be appointed by the Governor, no more than three of whom shall be of the same political party, and six members who shall be appointed by the President Pro Tempore of the Senate, no more than three of whom shall be of the same political party, and six members who shall be appointed by the Speaker of the House of Representatives, no more than three of whom shall be of the same political party. The appointed members of the Council shall be citizens of the State who, during their respective terms, shall hold no other state office to which any salary is attached except that of membership of the Environmental Quality Board.

The term of office of each appointed member shall be three years, measured from the third Tuesday of January of the year in which he takes office or until his successor has been appointed.

The Citizens Advisory Council shall include persons knowledgeable in fields related to the work of the Department of Environmental Protection such as, but not limited to, ecology, limnology, toxicology, pharmacology, organiculture, and industrial technology.

The Council shall annually elect one of its appointed members as Chairman and shall elect a Secretary who need not be a member of the Council. Meetings of the Council shall be held at least quarterly or at the call of the Chairman.

The Council shall have the power to employ and fix the compensation of such experts, stenographers, and assistants as may be deemed necessary to carry out the work of the Council, but due diligence shall be exercised by the Council to enlist such voluntary assistance as may be available from citizens, research organizations, and other agencies in Pennsylvania or elsewhere, generally recognized as qualified to aid the Council.

#### Section 1922-A. Citizens Advisory Council

- (a) The Citizens Advisory Council shall review all environmental laws of the Commonwealth and make appropriate suggestions for the revision, modification and codification thereof.
- (b) The Council shall consider, study, and review the work of the Department of Environmental Protection and for this purpose, the Council shall have access to all books, papers, documents and records pertaining or belonging to the department.
- (c) The Council shall advise the department on request, and shall make recommendations upon its initiative, for the improvement of the work of the department.
- (d) The Council shall report annually to the Governor and to the General Assembly and may make such interim reports as are deemed advisable.

## **ACT 95 OF 1992, THE AIR POLLUTION CONTROL ACT**

#### Section 7.6. Advice to Department

(a) The department shall consult with the Citizens Advisory Council established under Section 448 of the Act of April 9, 1929 (P.L. 177, No. 175), known as "The Administrative Code of 1929," as appropriate, in the consideration of State implementation plans and regulations developed by the department and needed for the implementation of the Clean Air Act. Nothing in this section shall limit the Council's ability to consider, study and review department policies and other activities related to the Clean Air Act implementation as provided under Section 1922-A of "The Administrative Code of 1929." This section shall not apply to state implementation plans or portions thereof comprised of permit emission offset or reasonably available control technology requirements for individual sources; consent orders and agreements; or regulations. The requirements of this section shall not apply to State implementation plans submitted by a local air pollution control agency.

#### **Section 4.3. Evaluation**

Beginning five (5) years after the effective date of this section and every five (5) years thereafter, the department shall conduct and submit to the General Assembly an evaluation of the effectiveness of the programs adopted to implement the Clean Air Act. The evaluation shall include:

(6) A summary of the activities undertaken by the Citizens Advisory Council and the air technical advisory committee under Section 7.6.
