WHEREAS, Jolene Chinchilli has served with distinction as a member of the Citizens Advisory Council to the Pennsylvania Department of Environmental Protection from her appointment by Governor Tom Ridge on June 27, 1996, to May 2013; and

WHEREAS, Jolene served on the Lower Susquehanna Regional Committee for the State Water Plan; and

WHEREAS, her leadership and expertise have been instrumental in guiding and facilitating Council's efforts in addressing key environmental concerns facing Pennsylvania; and

WHEREAS, her common sense approach to and unique perspective on environmental issues and public health has helped Council to be effective in addressing environmental concerns facing Pennsylvania; and

WHEREAS, her commitment and dedication, which were demonstrated by her active participation and attendance at full Council, committee and regional meetings during her tenure, has helped Council to be effective in implementing its mandate to protect the Commonwealth's air, soil and water; and

WHEREAS, she represents the ideals of volunteerism and portrays leadership, commitment, integrity and selflessness.
