#### Hazardous Sites Cleanup Act

#### HSCA, Act 108 of 1988:


- Need to promptly and comprehensively address hazardous substance releases.
- Provides funding and authority to conduct (or enforce) cleanup actions at hazardous waste sites to mitigate releases.
- Allows PA to participate in the cleanup of sites under the Federal Superfund Program.

- State Superfund (HSCA)
- Administration of PA's Land Recycling Program
- Federal Superfund (CERCLA)
- Hazardous Waste Regulatory Programs

# HSCF Complement Summary

- HSCA funds support some positions in the following Department programs: Environmental Cleanup and Brownfields, Waste Management, Office of Chief Counsel, Grants Center and Administrative Support.
- 194 of the 233 positions in DEP's HSCF Complement are currently filled statewide.




#### HSCF Program Revenue

# **Potential Impacts of HSCF Deficit**

- Brownfield and Small Business Grants reduced or discontinued
- Shut-down existing projects according to a priority plan
- No new responses unless immediate threats are confirmed
- Freeze vacancies and operational expenses
- Transfer costs to other funding sources

#### PA's Land Recycling Program Cornerstones


- 1. Uniform cleanup standards based on health and environmental risks.
- 2. Standardized DEP review procedures.
- 3. Relief from liability.
- 4. Financial assistance.

#### PA's Land Recycling Program Goals

- Encourage private sector cleanup of contaminated, vacant or otherwise underutilized properties and return them to productive use.
- 2. Stimulate economic growth via development of brownfield properties.
- 3. Encourages local government partnerships with business.
- 4. Maximizes the use of existing infrastructure, thereby preserving prime farmland, open space and natural areas.

#### Act 2

DEP approved 365 final reports submitted for actions during FY 2019-20. Over the 25year history of the Land Recycling Program, DEP has approved over 7,470 actions.
