# **DEP Secretary Quigley to Chair Pipeline Infrastructure Task Force**



The task force will provide a final report detailing its findings to Gov. Tom Wolf by February 2016.

HARRISBURG -- Gov. Tom Wolf this week announced the appointment of 48 individuals to participate on the Pennsylvania Pipeline Infrastructure Taskforce, which will be chaired by DEP Secretary John Quigley. The group of experts and stakeholders will recommend policies, guidelines and best practices to guide the anticipated and unprecedented build-out of pipeline infrastructure expected to take place across Pennsylvania during the next decade.

"Pipeline expansion is important to our economy and growing energy sector," Gov. Wolf said. "We will work together to make sure that this important infrastructure can be developed effectively and responsibly with consideration for the environment, residents and local communities."

The task force is made up of representatives from state agencies, the legislature, federal and local governments, the pipeline and natural gas industries and environmental groups. Experts were drawn from across the state and country.



# **DEP Completes First Round of Monideatoring Near Carbon County Mine Fire**

WILKES-BARRE -- DEP has completed a first round of air quality monitoring near the Jeansville mine fire in Banks Township, Carbon County. Initial air quality results do not indicate an actionable level of gases near the fire. However DEP will continue monitoring with more sensitive detection equipment for hydrogen sulfide to ensure the safety of nearby communities.

On several days in the vicinity of Tresckow and north of the mine fire, the department detected low levels of hydrogen sulfide. A very low level of carbon monoxide was also detected one day. The Aug. 12

levels were near the lower detection limit of the instrument and not at a level that requires action. Hydrogen sulfide is a colorless gas that can emit an odor of rotten eggs; carbon monoxide is both odorless and colorless.

In response to the detections, DEP acquired a more sensitive instrument, called a JEROME® J605 Gold Film Hydrogen Sulfide Analyzer. Seven air quality staffers were recently trained on how to use the hand-held device that can detect hydrogen sulfide at much lower levels.

# Recreational Restrictions Lifted on Conewago Creek near Site of Miller Chemical Fire

HARRISBURG -- Cleanup efforts continue at the site of the June 8 fire at Miller Chemical, a fertilizer plant in Adams County.

Recreational restrictions have been lifted for the Conewago Creek after water samples taken at various times and locations since the fire indicate the waterway is again suitable for fishing, swimming and boating.

Contaminated runoff water and soil currently stored onsite is being hauled to treatment facilities for proper disposal. Debris from the fire and contaminated soil is being taken to a local landfill.

The Department of Environmental Resources was created by Act 275 of 1970, which abolished the Department of Forest and Waters. The Department of Forest and Waters was created by the General Assembly in 1901.

# **DEP Interns Learn about Water Management, Public Service**

HARRISBURG -- Approximately 40 interns from DEP's Office of Water Management met with Water Management Deputy Secretary Kelly Heffner and other staff on July 7 to discuss how DEP protects Pennsylvania's water resources as well as the rewards of working in public service.

The event was held at Fort Hunter Park in Dauphin County to provide access to the Susquehanna River where DEP's Josh Lookenbill and staff from the Bureau of Point/Nonpoint Source Management, Division of Water Quality Standards gave the students a tour of DEP testing locations on the river as well as an on-land presentation on the responsibilities of staff to ensure water quality to the citizens of the Commonwealth.

Lookenbill leads DEP's team who, along with Pennsylvania Fish and Boat Commission, the Susquehanna River Basin Commission, and the United States Geological Survey, have undertaken a multi-year study of the river to investigate a number of issues facing the smallmouth bass population.
