DEP Secretary Reiterates Need for Major Technology Investment Before Senate Panel

HARRISBURG -- DEP Secretary John Quigley testified before members of the newly formed Senate Subcommittee on Infrastructure, Environment and Government Operation on March 14 to talk about Governor Tom Wolf's 2016-17 proposed spending plan for the agency.

The Senate Appropriations Committee has created four subcommittees with specific department focuses, each with a Majority Chair and Minority Chair. Their purpose is to more thoroughly review department and agency spending.

Secretary Quigley answered questions about the governor's proposed severance tax on natural gas, the solvency of DEP's 12 special funds, and the success rate of DEP's Permit Review Process and Permit Decision Guarantee. But much of the discussion centered on DEP's need for a significant investment in information technology to allow the agency to meet its mission.

"Agency staff are using antiquated tools to permit and monitor industries equipped with 21st Century technology, " Secretary Quigley said.

DEP began air monitoring and sampling in Lackawanna County last month to collect data for a health study by the Department of Health (DOH) near Keystone Sanitary Landfill in Dunmore. The three-month monitoring and sampling period will provide both agencies with information on what type of particles and vapors are in the air and what people in the surrounding area are breathing.

DEP Conducts Mine Rescue Safety Training Drill

SCRANTON -- Staff from DEP's Deep Mine Safety program conducted a mine rescue drill for local mining rescue teams on March 16 at the Lackawanna Coal Mine in Scranton.

The focus of the drill was to educate miners on proper techniques for dealing with a mine fire as well as the rescue of a patient. Teams of three entered the mine and had to safely address: carbon monoxide and methane levels, a fire below and rescuing a miner trapped deep in the mines. Each team was evaluated for its performance.

The Deep Mine Safety program staff is required to hold these drills twice a year.

DEP Issues NPDES Permit for Natural Gas-Fired Power Plant in Lackawanna County

WILKES-BARRE -- DEP has issued a National Pollution Discharge Elimination System (NPDES) permit to Lackawanna Energy Center, LLC of Chicago to discharge treated wastewater from a proposed 1500-megawatt natural gas-fired power plant to be constructed on Industrial Drive in Jessup, Lackawanna County. The permit authorizes the company to discharge into nearby Grassy Island Creek.

"The department thoroughly reviewed Lackawanna Energy's application and found that it met the criteria for discharge regulations," said Mike Bedrin, Director of DEP's Northeast Regional Office in Wilkes-Barre.

HARRISBURG -- Travelers who park at Harrisburg International Airport will soon be able to charge their electric vehicles.

A Level 3 DC fast charger has been installed at the cell phone lot as part of an Alternative Fuels Incentive Grant to Car Charging Group (CCGI) to install chargers throughout Pennsylvania. The charger will be operational beginning next week. HIA and CCGI have also obtained permits to install an additional DC fast charger in the short term parking garage.

DEP Issues Public Notice for Lead Exceedance in Drinking Water Served by Berks County Vendor

HARRISBURG -- DEP has notified the public about a violation of the lead standard applicable to the drinking water sold at Crystal Spring Water, a company that sells water through vending machines in Adamstown, Berks County. The Department's notice does not apply to Crystal Spring Bottled Water, which is an unrelated company.

A routine test sample collected by the owner in September 2015 contained a lead level of 16 parts per billion (ppb) which is above the maximum contaminant level of 5 ppb. According to the Safe Drinking Water Act, the owner of Crystal Spring should have notified DEP within 24 hours of receiving this test result and should have notified customers within 30 days. Neither notification was given.

MEADVILLE -- Six employees from DEP's Northwest Regional Safe Drinking Water Program and Office of Chief Councel were part of a team honored with the Legal Aid Excellence Award for their work to help residents of Hardwood Estates Mobile Home Park located outside of Conneaut Lake in Crawford County.

More than 24 people who live in the park were left without a reliable public water system after the property owner abandoned it in 2012. The DEP employees, with the help of Legal Aid and several other organizations, helped the residents form an association and secure funding to repair the water system's chlorinator, obtain necessary permitting, hire a properly trained certified water operator, and ultimately take ownership of the mobile home park through a judicial sale in April 2015. This action enabled the residents to remain in their homes.

"This example of your work with the general public is yet another remarkable story of DEP employees going above and beyond our day-to-day jobs and is a perfect indication of the commitment and dedication I see every day amongst your peers at DEP," DEP Secretary John Quigley said. "Congratulations for a job well done!"
