DEP Secretary to Lawmakers: Continuing Budget Cuts Hurt the Economy and the Environment

HARRISBURG -- DEP Secretary John Quigley provided testimony before the House Appropriations Committee on March 1 about Governor Wolf's proposed Fiscal Year 2016/2017 budget for the department.

Quigley underscored the crippling impact that severe budget cuts have had on the agency during the past decade at a time when regulatory responsibilities and the workload of employees is increasing.

"Here is an important example of the two paths we face: cuts have been made in the past to meet short-term deficits, and this has hurt Pennsylvania businesses that rely on our permits and Pennsylvania communities that rely on our protection," Quigley said. "The choice in front of us is to choose a path that addresses the structural deficit and avoids further cuts, or continue this path we're on – where cuts hurt the economy and the environment."

HARRISBURG -- The House Agriculture and Rural Affairs, and Environmental Resources and Energy committees held a joint informational meeting on Feb. 29 to discuss the Wolf Administration's strategy to reduce pollutants entering the Chesapeake Bay. The administration recently announced its strategy in anticipation of the state missing its 2017 reduction targets for nitrogen and sediment.

DEP Secretary John Quigley and Agriculture Secretary Russell Redding were among those who testified about the new plan that was developed jointly by the departments of Agriculture, Conservation and Natural Resources (DCNR), and DEP, as well as the State Conservation Commission. The strategy relies on a mix of technical and financial assistance for farmers, technology, expanded data gathering, improved program coordination and capacity and – only when necessary – stronger enforcement and compliance measures.

"Local water quality in Pennsylvania is a shared responsibility, and we believe that collaboration, partnerships, commitment, and resources are the key to the success of the effort, " Quigley said. "If every farmer, community and citizen does their part, we will restore and safeguard local water quality in Pennsylvania, and help to restore the quality of the Chesapeake Bay."

DEP Approves Coudersport Borough Authority Well Use

WILLIAMSPORT -- DEP has granted approval to the Coudersport Borough Authority, to begin using two drinking water wells that had been out of service since September due to a surfactant spill at a JKLM Energy well pad in Sweden Township, Potter County.

"The results of sampling done in late December by DEP and the authority indicate all drinking water parameters are well below maximum contaminant levels or were not detected," DEP Regional Director Marcus Kohl said. "All other parameters were not detected or at minute safe levels."

contaminated with radioactive material was shipped from a PSC Metals Inc. facility in Beaver Falls, to two facilities in Ohio. A radium-226 source of unknown origin was accidentally shredded with other materials, then shipped to processing facilities in Ohio.

A team from DEP's Radiation Protection Program took extensive readings at the Beaver Falls scrapyard. Elevated readings were found on one large metal shredder and on gloves used by two workers. DEP is performing additional testing to ensure that there was no skin contamination. Radium-226 can be harmful if ingested.

WILKES-BARRE -- DEP has changed the date of the public hearing regarding IESI Landfill's permit application to expand its existing facility on Applebutter Road in Bethlehem, Northampton County. The hearing will take place from 6 to 9 p.m., Wednesday, April 13 at Saucon Valley High School, 2100 Polk Valley Rd., Hellertown. The original date of the hearing was Wednesday, March 16.

The company is requesting an expansion of 6 acres, with 22.5 acres overtopping existing landfilled areas. Residents will be allowed to give public testimony regarding the application.

Roundtable Visits Geisinger Community Medical Center to Learn about Sustainability Program

SCRANTON -- Members of the Pennsylvania Association of Environmental Professionals including DEP staff, held their quarterly Pollution Prevention and Energy Efficiency Roundtable Feb. 18 at Geisinger Community Medical Center, Scranton, where they learned about the hospital's Sustainability Program.

Specific energy saving and environmental initiatives include a cogeneration power plant on Danville's main campus, EPA ENERGY STAR certification, installing energy-efficient LED lighting fixtures, alkaline battery and eyeglass recycling and securing LEED-Certified for its buildings. Geisinger has managed nearly \$700,000 in energy savings annually while expanding 110,000 square feet. These energy savings were due to a reduction in electricity and natural gas use.

Some of the technologies that Geisinger incorporated were T8/LED lighting; variable frequency drives, occupancy sensors, high efficiency modulating boilers, and variable frequency drive chillers. Geisinger also takes into account the public health impacts of reducing energy use.

Live Webstream Captures Courtship, Falcon Style

HARRISBURG -- The courtship of the pair of peregrine falcons that nest on a ledge of the Rachel Carson State Office Building is on full display through DEP's live falcon cam.

This morning, the male falcon was seen bringing the female her breakfast that consists of small birds of prey. This food offering is part of the courtship/pair bonding process. After she lays the eggs, she will do the majority of the incubation (although the male does some as well) while most of the hunting will be done by the male.

According to the Pennsylvania Game Commission, the food source is tied to the number of eggs she will lay. For example, if prey is highly abundant and high quality, then more eggs are laid. On average, peregrines will lay between 3-5 eggs. In 2015, she laid 4 eggs, with the first one arriving on March 14.
