# **DEP Releases Latest Revisions of Oil and** Gas Rulemaking


HARRISBURG, PA -- DEP recently announced the draft final revisions to the "Environmental Protection Performance Standards at Oil and Gas Well Sites" rulemaking (Chapters 78 and 78a). This revision continues DEP's commitment to modernizing and strengthening the environmental controls employed by both the conventional and unconventional industries to assure the protection of public health, safety, and the environment.

"Responsible energy development in Pennsylvania is key to the commonwealth's future," said DEP Secretary John Quigley. "We are committed to protecting our natural resources, and these rules strengthen safeguards for our water and environment."

"These rules are the culmination of one of the largest public participation efforts the department has ever seen, with nearly 30,000 comments and 12 public hearings during two public comment periods," said Quigley.

# **DEP Studies Shipwreck in Lake Erie**

ERIE, PA -- On August 12, DEP staff went aboard the Regional Science Consortium boat to study the S. K. Martin shipwreck site.

Each year, DEP staff visit several shipwreck sites in Lake Erie to document ecological habitats and historical artifacts. DEP deploys a remote operated vehicle to depths of up to 60 feet to observe the shipwrecks' present condition and to record the presence of any

This annual initiative is managed by DEP's Coastal Resources Management Program and funded by a Section 309 Enhancement Grant from the National Oceanic and Atmospheric Administration.

The S.K. Martin was first launched in 1883 as a passenger ship. It was converted to a bulk freighter in 1888 and was sunk when it sailed through a northwest gale while fully loaded with coal.

# DEP Offers Funding for Projects to Improve Local Water Quality by Reducing Stormwater Runoff

HARRISBURG, PA -- DEP has opened a grant program to control urban stormwater and improve local water quality. Municipalities, including cities, boroughs, or incorporated towns within the Chesapeake Bay Watershed are eligible to apply.

"Urban stormwater runoff has a big role in local water quality, it's so important to manage that stormwater properly to prevent pollution from reaching our waterways," said DEP Secretary John Quigley.

These grants will serve as a valuable tool to enable local governments to improve their urban stormwater management and ultimately, their water quality and that of their neighbors downstream."

# Secretary Quigley Discusses Pipelines on PCN's Environmental Focus

HARRISBURG, PA -- DEP Secretary John Quigley recently spoke to Bob Oltmanns on Environmental Focus, a program provided by the Pennsylvania Environmental Council that airs on PCN.

During the interview, Quigley talked about the difficulty drillers have in getting their gas to market in a way that does not impact communities or the environment. As a result, Governor Wolf created the Pipeline Infrastructure Task Force, of which Quigley is chair, to develop a list of best practices for the planning, development, operation, and maintenance of natural gas pipelines.

Quigley emphasized the need for Pennsylvania to develop a worldclass pipeline infrastructure system that does not negatively impact public health or the environment.

### The Ephrata Area Joint Authority Water Treatment Plant receives the "President's Award" recognition from the Partnership for Safe Water

HARRISBURG, PA -- The Ephrata Area Joint Authority water treatment plant, located in Lancaster County, recently received the "President's Award" from the Partnership for Safe Water (PSW). The treatment plant provides drinking water service to approximately 17,937 people.

The President's Award recognizes achievement in stringent individual filter performance goals for turbidity. The Ephrata Area Joint Authority is the ninth plant to receive this award from the PSW in Pennsylvania.

The PSW is made up of DEP, the U.S. Environmental Protection Agency, the Pennsylvania Section American Water Works Association, and other drinking water organizations. Its goal is to implement preventative measures that are based on optimizing treatment plant performance and maximizing the protection of public health.

As of today, only 22 water treatment plants in the nation have received the President's Award from the PSW.
