Subject: Notification of Three Mile Island Implementation of Permanently Defueled

On January 20, 2021 Three Mile Island (TMI) will be implementing the Permanently Defueled Emergency Plan (PDEP) and associated Emergency Action Levels (EAL). The PDEP changes were approved by the Nuclear Regulatory Commission (NRC) in the above referenced letters. The changes to the PDEP are consistent with the lower risk associated with the current decommissioning status of TMI.

The following are a few highlights for the changes to the Three Mile Island Emergency Plan based on implementation of the PDEP.

- Since the risk of a potential offsite radiological event has been greatly reduced, the Emergency Planning Zone (EPZ) has been reduced to the Site's Area Exclusionary Boundary and the Plume (10 mile) and Ingestion (50 mile) Emergency Planning Zones (EPZ) are no longer required.
- The Emergency Action Levels were revised to reflect that an Alert would be the highest classification level.
- Emergency Classifications will be made within 30 minutes of conditions meriting an EAL classification and the NRC, Pennsylvania Emergency Management Agency (PEMA), Dauphin and Lancaster Counties will continue to be notified.
- All emergency actions will be completed by the onsite staff and therefore the Emergency Operations Facility in Coatesville, PA will not be utilized.

- The Alert Notification System Sirens are no longer needed. In order to preclude an inadvertent actuation of a siren, all power will be removed from the sirens by early March. The sirens will soon be physically removed.
- Exelon will continue to perform annual reviews of Emergency Plan and EALs with the Commonwealth.
