Dear Mr. Vincent:

The Department received your letter dated January 9, 2014, requesting termination of Plan Approval 60-00022A, due to the company's loss of control of the site upon which the facility was planned to be constructed. On the basis of your voluntary request and loss of control of the site, the Department is hereby terminating Plan Approval 60-00022A effective January 10, 2014. Plan Approval 60-00022A that was issued on September 27, 2013 for the construction of a tire-derived fuel/natural gas-fired two stage combustion process and ancillary sources to be located in White Deer Township, Union County, has been terminated. A notice and brief description of this action will be published in the *Pennsylvania Bulletin* regarding the termination of Plan Approval 60-00022A previously issued to EN-TIRE Logistics of Milton PA, LLC.

Any person aggrieved by this action may appeal, pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. Section 7514, and the Administrative Agency Law, 2 Pa. C.S. Chapter 5A, to the Environmental Hearing Board, Second Floor, Rachel Carson State Office Building, 400 Market Street, PO Box 8457, Harrisburg, PA 17105-8457, 717-787-3483. TDD users may contact the Board through the Pennsylvania Relay Service, 800-654-5984. Appeals must be filed with the Environmental Hearing Board within 30 days of receipt of written notice of this action unless the appropriate statute provides a different time period. Copies of the appeal form and the Board's rules of practice and procedure may be obtained from the Board. The appeal form and the Board's rules of practice and procedure is also available in braille or on audiotape from the Secretary to the Board at 717-787-3483. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.

IF YOU WANT TO CHALLENGE THIS ACTION, YOUR APPEAL MUST REACH THE BOARD WITHIN 30 DAYS. YOU DO NOT NEED A LAWYER TO FILE AN APPEAL WITH THE BOARD.
