Dear Mr. Bellas:

This letter serves as notification of the intention of Grand Central Sanitary Landfill, Inc. (GCSL) to formally withdraw the minor permit amendment application submitted to the Pennsylvania Department of Environmental Protection (PA DEP) on March 14, 2018. The intent of the application was to amend the GCSL solid waste permit to include operation of the Slate Belt Heat Recovery Center (SBHRC) facility proposed for an area of land on the Grand Central Sanitary Landfill site, located adjacent to the Green Knight Economic Development Corporation Inc. (GKEDC) facility in Plainfield Township, Northampton County, Pennsylvania.

Despite the progress made in addressing concerns raised by residents and other interested parties, and after a significant investment of resources and time by GCSL, GKEDC, the Plainfield Township Planning Commission, and PA DEP, we regret that the project will not proceed at the proposed location. Please extend our appreciation to the team members at PA DEP who participated in the lengthy permit application review process for this challenging project.
