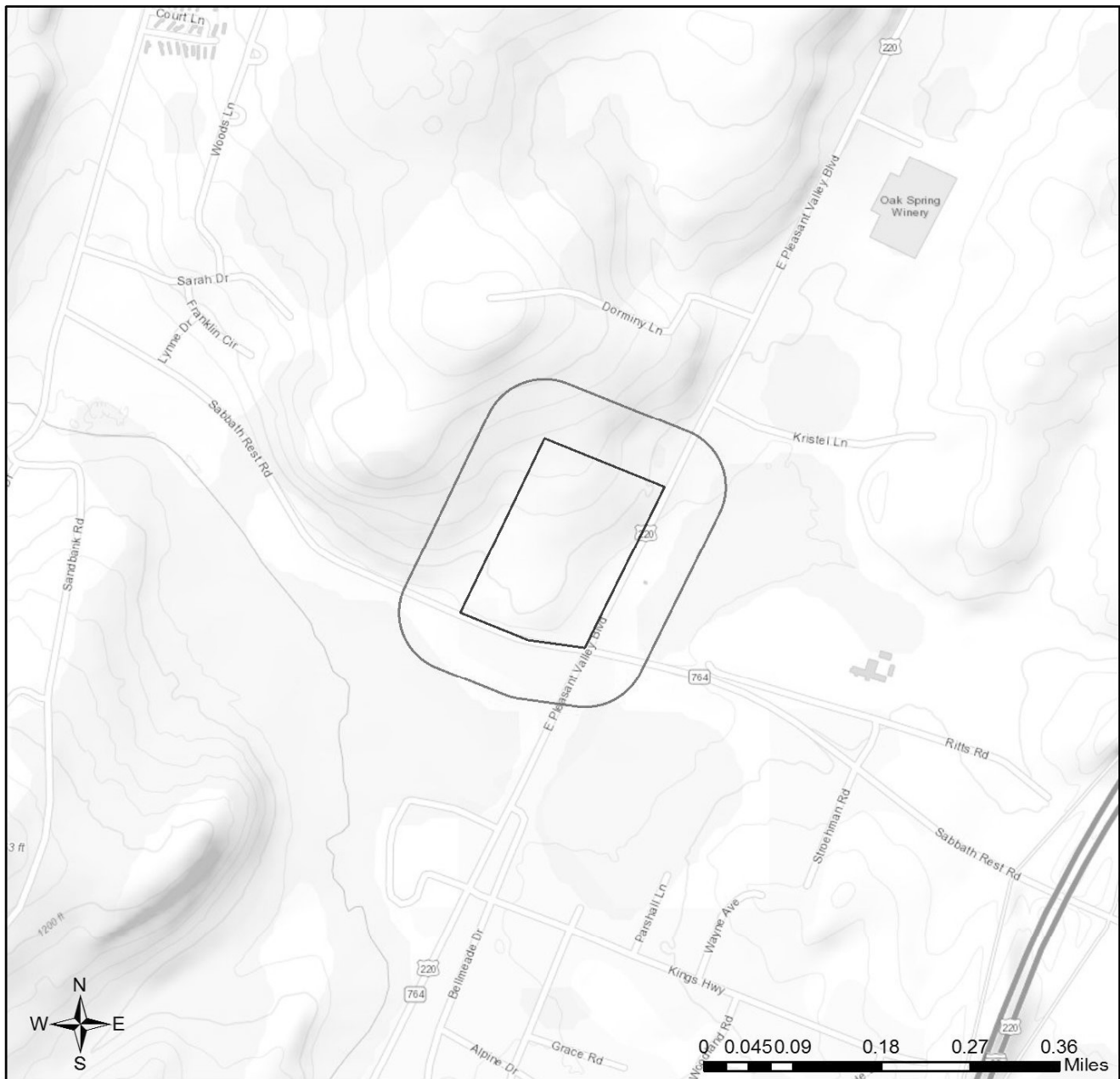


- Project Boundary
- Buffered Project Boundary



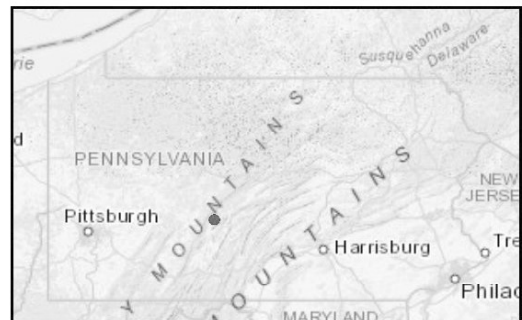
