In compliance with the provisions of the Clean Water Act, 33 U.S.C. Section 1251 <u>et seq</u> ("the Act") and Pennsylvania's Clean Streams Law, as amended, 35 P.S. §§ 691.1 <u>et seq</u>., the Berks County Conservation District hereby authorizes the **minor plan modification** to the NPDES permit for Stormwater Discharges Associated with Construction Activities from the Birdsboro Power Project's Natural Gas Combined Cycle Power Plant Facility, located along Armorcast Road in the Borough of Birdsboro and Union Township, to the Hay Creek (CWF, MF) and the Schuylkill River (WWF, MF). **The revisions include the items noted on the attached document.** 

PAC060046 was effective on <u>03/23/2017</u> and will expire on <u>03/22/2022</u>. All dischargers are required by Sections 402 and 611 of The Clean Streams Law, 35 P.S. §§691.402 and 691.611 to comply with the terms and conditions of their permit.
