Dear Mr. Human:

On February 14, 2022, the Department of Environmental Protection (DEP) received a PSD Plan Approval application from Sunoco Partners Marketing & Terminals, L.P. (SPMT), for the proposed expansion of the current ethane processing capacity at its existing Marcus Hook Industrial Complex (MHIC) facility from 75,000 barrels per day (*bpd*) to 85,000 *bpd*.

On March 1, 2022, DEP received proofs of receipt for the notifications to the municipality and county made in accordance with 71 P.S. § 510-5 (Act 14 of 1984) and 25 Pa. Code § 127.43a.

On March 9, 2022, DEP received additional information from Environmental Resources Management (ERM), on behalf of SPMT, pertaining to the design and plant layout of the ethane chiller train and boil-off gas system proposed to be installed as part of the expansion.

Also, on March 9, 2022, DEP received Change of Ownership and Compliance Review forms from SPMT indicating that, effective March 1, 2022, SPMT changed its company name to Energy Transfer Marketing & Terminals, L.P., and the facility name to Marcus Hook Terminal. (DEP has since updated its database to indicate the new names.)

Pursuant to 25 Pa. Code § 127.12d, DEP has reviewed the PSD Plan Approval application to determine whether it contains the necessary documents to be considered administratively complete. Please be advised that the application package contains sufficient detail to enable DEP to conduct the technical review and has been accepted for that purpose.

This is not a final action by DEP on this application. Plan Approval applications undergo a series of reviews before DEP reaches a final decision. The completeness review is the first in a

series of reviews conducted by DEP. The Plan Approval application will now move to the technical review stage of the Plan Approval review process.
