Electronics Recycler Selection:

There are two ways to help ensure that responsible recycling practices are followed by your selected electronics recycler:

- Select a certified electronics recycler;
 or
- 2) Follow a selection checklist with recommended guidelines for the selection of an electronics recycler.

1) Selection of a Certified Electronics Recycler:

There are two reliable certification standards which now exist under which electronics recyclers can become certified:

- a. The Responsible Recycling (R2) Practices
- b. e-Stewards

IMPORTANT NOTE: Companies can apply to the certifying bodies for each of these standards to become certified. Companies undergo a very stringent audit and review process by the certifying body. If the company proves that it meets the stringent standards of the R2 Practices or e-Stewards, then the company receives either R2 certification or e-Stewards certification respectively. EPA believes that companies that follow the R2 Practices or e-Stewards will raise the level of performance of the electronics recycling industry, and enable the public to have much greater assurance that environmentally responsible recycling practices are being followed.
