Don Hershey, executive Director, PA-AWWA section indicated "we had twelve members sign up for the Program within the first few weeks and keen interest by others as the word got out." The systems that joined early can consider themselves Charter Members under the guidelines set by AWWA. This entitles them to some unique benefits of the Program including participation in the development and input as the Program evolves, a plaque recognizing the utility as a Charter member and recognition by State and Federal Regulators as well as their peers. Don went on to note, "North Penn Water Authority was the first in the state, if not the Nation, to sign on to the Program. Their professionalism and attention to detail made the Program a perfect fit." North Penn and it's sister organization North Wales Water Authority have long been members of the AWWA family participating in the Treatment Plant Optimization Program, attaining the Phase III level of treatment for many years and currently working toward their Phase IV status. Dan Preston, P.E., Director of Operations and Engineering for North Penn stated, "the Partnership Programs have always been a part of our organization, they have set the bar and provided the tools necessary to get the job done. We have accepted the challenge in meeting the optimization goals, both in treatment and now in the distribution area and we feel we owe this to our Customers recognizing that they should expect nothing less."

The objective of the Partnership for Safe Water optimization programs are to identify those opportunities for improvement in system operations and to empower system operators with knowledge to recognize and apply procedures that result in water quality and system reliability improvements. We in the Partnership for Safe Water Program welcome North Penn Water Authority and the eleven other Charter Members to the new Distribution Program. They are: Brodhead Creek Regional Authority, Chester Water Authority, City of Allentown, City of Lancaster, Dover Township Water Dept, Elizabethtown Area Water Authority, Oakmont Water Authority, Pennsylvania American Water multiple counties statewide, Philadelphia Water Dept, Reading Area Water Authority, and Western Berks Water Authority.

## Partnership for Safe Water Program REPRESENTATIVE WANTED in Central Pennsylvania

The Pennsylvania Section of the American Water Works Association (PA-AWWA) is seeking a representative for the Partnership for Safe Water program (PfSW).

The PfSW focuses on optimizing the operation of water systems and is supported by both the Pennsylvania Department of Environmental Protection (DEP) and the Section. The representative will visit water systems in Central Pennsylvania.
