

Supporting Local Countywide Action Plan Implementation in Pennsylvania

Pennsylvania is working alongside neighboring states to clean up our local waters that flow to the Chesapeake Bay. This effort is part of Pennsylvania's Phase 3 Chesapeake Bay Watershed Implementation Plan (Phase 3 WIP). The path to success for Pennsylvania's Phase 3 WIP starts locally and is all about partners, projects and progress! Pennsylvania counties have created and are implementing local, county-developed action plans. These plans guide their efforts to reach their goals of reducing nutrient and sediment pollution in their local waters. Their collective effort, with support from state and federal action leaders, will clean up local streams and rivers across Pennsylvania's Chesapeake Bay watershed.


Local Goals, Local Implementation

Clean water efforts at the county level are the foundation of Pennsylvania's Phase 3 WIP. The Phase 3 WIP identifies nitrogen and phosphorus pollution reduction goals for each county. Achieving these goals will reduce pollution in Pennsylvania's local waters, and ultimately the Chesapeake Bay. State and local action leaders are demonstrating their commitment to clean water by supporting efforts in 34 counties in the Chesapeake Bay watershed as they implement Countywide Action Plans (CAPs).

New partnerships, ideas and funding sources are needed to get the job done. As part of this process, the Pennsylvania Department of Environmental Protection (DEP), the Pennsylvania Department of Agriculture (PDA) and the Pennsylvania Department of Conservation and Natural Resources (DCNR) partnered early in the process to form a Pennsylvania Phase 3 WIP State Team. The State Team, locally-led CAP Implementation Teams and local stakeholders are taking collective action to implement Pennsylvania's Phase 3 WIP. This is an adaptive and ever-evolving process that relies on continued support and commitment from the State Team action leaders, CAP Implementation Teams, legislators, nonprofit partners and academia.

The Pennsylvania Phase 3 WIP State Team relies on the leadership of the three agency Secretaries from DEP, PDA and DCNR. In 2019, DEP invited members of the statewide Phase 3 WIP Steering Committee that guided the development of the Phase 3 WIP to continue as members of the State Team to support implementation. DEP also invited additional public and private sector members with diverse and applicable skill sets to join the State Team. The State Team meets on a bi-annual basis and in sector-specific workgroups (Forestry/Wetlands, Stormwater/Wastewater, and Agriculture) to:

- Support the implementation of CAPs
- Review and revise milestones in the Pennsylvania Phase 3 WIP
- Provide needed programmatic support and updates
- Evaluate programmatic recommendations submitted by county partners
- Adapt the overall strategies, as needed, to reach our collective goals





Program Support

Since 2017, major new initiatives and programs have been developed to accelerate Pennsylvania's progress towards achieving nutrient and sediment reduction goals. This includes programmatic changes Pennsylvania has made or is making to support CAP implementation, including:

The Pennsylvania Clean Streams Fund, created in 2022, established a new Agriculture Conservation Assistance Program to help farmers implement water quality best management practices (BMPs). The Clean Streams Fund also enabled DEP to reinvigorate the Act 167 Stormwater Management Planning Program to provide grants to municipalities to plan and carry out stormwater runoff reduction measures. Further, the fund supports DEP's abandoned mine drainage reclamation, PDA's assistance to farmers for development and implementation of nutrient management plans, and DCNR's urban tree planting programs.

Funding Support

Action Steps

DEP's Chesapeake Bay Watershed Restoration Division staff and regional office CAP support teams are taking action steps to support and coordinate local CAP implementation efforts and progress across 34 counties:

Communication and training

- o Outreach and training through webinars and topic-specific meetings to assist counties with implementation.
- Regular one-on-one county meetings to address county questions, issues and concerns
- Pennsylvania Clean Water Academy (CWA): a vast online library of webinars, workshops, FAQs and other assistance tools and resources for CAP Coordinator and County Implementation Teams.

Reporting and Tracking Progress

- Pennsylvania tracks and reports WIP and CAP progress every year. The adaptive, evolving nature of the Phase 3 WIP is evident in the Biennial Milestone Reporting, when the State Team members re-evaluate their WIP initiatives to identify new and update existing opportunities.
- Counties follow the same process as the State Team in reporting annual progress on CAPs and conducting biennial CAP initiative updates to ensure the CAPs continue to support the counties' local clean water efforts.



Connecting County and Local Partners with Statewide WIP Action Leaders to Support CAP and WIP Implementation
