Stage II Dispenser Replacement Information

This document is intended to provide instruction and assistance relating to the Suspension of Enforcement of the Stage II Vapor Recovery Requirements for Control of Emissions of Volatile Organic Compounds from New and Modified Gasoline Dispensing Equipment in the Philadelphia and Pittsburgh-Beaver Valley Areas published on November 12, 2016 in the Pennsylvania Bulletin. This supplements that notice; it does not change it.

The suspension of enforcement applies when an owner or operator of a gasoline dispensing facility replaces old gasoline dispensers or adds new gasoline dispensers for an existing tank system after November 12, 2016.

Please ensure that copies of all records of the work done are kept on site with Stage II records, including completed checklists and results of the required pressure decay testing (and tank tie testing, as appropriate) to document the work that was done.

Please submit notice to the appropriate DEP regional office, Philadelphia Air Management Services, or Allegheny County Health Department prior to beginning work on the system. Please submit the notice at least 30 days prior to the activity to the appropriate address listed below. Please note that 30 days prior notice is required for tank handlers for this type of work.

Note: the notice can be e-mailed for those contacts with e-mails listed below. In Philadelphia County, in addition to providing written notice, owners and operators should contact the Philadelphia Air Management Services at (215) 685-7572 or DPHAMS_Service_Requests@phila.gov to discuss additional requirements that may apply to equipment changes addressed in this notice.
