ID	Title	Description
45049	Add Correction Notice History to public view page and ensure applicant response verbiage displays in all correction history tabs - internal, external, public	History has to show verbiage sent by reviewer as well as verbiage in response from applicant in all locations - internal, external, and public view.
10510	Applicant must acknowledge receipt of permit determination	Acknowledgement page should be configurable by PERMIT (not program) and if turned 'ON' for that permit, then when that permit has a determination (Issue, Deny, etc.) - the next time the EFA logs into that account, prior to navigating to their dashboard, the acknowledgement page will pop up; there will be verbiage indicating DEP has made a determination on their permit; and when the user clicks OK they should be navigated to the tab page containing the determination on their dashboard.
44674	Left Menu for Internal e-permitting	Instead of modules being listed on the Overview tab, modules will be left menu items with the module details appearing to the right

40769	Asbestos - Add text to overview for Initial Notifications regarding upcoming fees	This language should be placed on the overview page of all Asbestos submission types  "Sometime in early 2021 the Department of Environmental Protection will begin charging \$300 for the submission of each initial asbestos notification (not revisions). The exact date the fee will begin is unknown at this time but will be based on the publication date of the regulation in the Pennsylvania Bulletin. This message will be updated and further information will be provided sometime in late 2020."
44675	Asbestos – Implementation of Fees	Ability to charge \$300 fee for Asbestos submissions. *Note* This will be functional in the user testing environment but will NOT be turned on in Production until the program area indicates.

ID	Title	Description
46435	Ability to see a Revoked Permit in External	A new tab on external dashboard which would only appear if there was a permit which had been revoked.  Internal Activity requires a letter to be uploaded - that letter is what should be visible on the 'view letter' button.
44735	Withdrawn link on dashboard should show Cover Letter	On the external user's dashboard, the Withdrawn/denied link should display the cover letter. right now, it is a hyperlink that does not contain anything.

44670	Ability to Revoke a permit	A new tab will be made available, visible by permissions, called Post Determination Activities. The ability to add/edit and/or view specific activities should also be permission based.  The top of this tab page should show the application block for the particular program area utilizing the system.  Initially this tab will have just one available activity called 'Revoke Permit' BWEW users should be able to see this tab (all roles)  BWEW reviewers, section chiefs, program managers should have EDIT capability for revoke permit  BWEW CCD users should have READ capability for revoke permit  A post determination activity will have a Begin and Completed date. Activities can be repeated multiple times, so no limit should be made on being able to add an activity multiple times; except that an activity cannot be added while the same activity is in progress.  Ex: A revoke permit activity has a begin date but was not yet completed; a user cannot add a new revoke permit activity until the first one is complete.  An activity cannot be deleted once it is completed. An activity cannot be edited once it is completed. That activity should be read only for all users.
44950	Correction text should also display on Correction Notice page in internal	Correction text should also display on Correction Notice page in internal so reviewers can see what will be sent to the client
4504	7 Updates during correction stay saved as draft and do not change 'officially submitted' data And ability to view versions in Internal	The current fix is that when an applicant is working on a correction notice response, the system does not actually make the changes/revisions until they hit the submit button to send the information back to DEP.  Also a Revision History, where DEP, the applicant/consultant, and public can see the actual iterations of the submissions.
