The language would change based upon whether it is a completeness or technical deficiency (correction notice) and whether or not the deficiencies are only minor
items (this allows us the flexibility to try and work small items out, which is in the PRP/PDG Policy).
Chapter 105 would also include its necessary eligibility deficiency language in the correction notice, similar to Ch. 102. This is a critical item for Go Paperless for 105.
