

#### WHAT'S NEW

Changes to this round of the Alternative Fuels Incentive Grant Program (AFIG) are highlighted below:

#### **Project Start Time and Duration**

Projects need to start on or after July 1, 2010. No project may exceed 24 months. No projects applied for may end later than June 30, 2012.

#### **New Application Format and Instructions (eGrants)**

Applications will be evaluated based solely on the data provided; therefore, completeness and accuracy are important. Applications that do not meet the requirements for the program will not be reviewed and are not eligible for funding.

- The application, project description and budget sheets must:
  - Be submitted; along with all required attachments, via the environmental eGrants system (www.grants.dcnr.state.pa.us);
  - Be complete, including: project description and all items contained in the application instructions;
  - o Include documentation supporting the anticipated energy savings; and
  - Be in compliance with all application conditions

#### **Incremental Cost Requirement for the Purchase of Alternative Vehicles**

Reimbursement cost of alternative fuel fleet vehicles will be limited to the incremental cost difference between the conventional fuel base model and the alternative fuel model.

#### **Alternative Fuels Incentive Grant General Guidelines**

The Pennsylvania Department of Environmental Protection (DEP) is offering reimbursement grant funding for clean, alternative fuel projects in Pennsylvania, and investment in Pennsylvania's energy sector. The primary goals of the Alternative Fuels Incentive Grant Program (AFIG) are to improve Pennsylvania's air quality and reduce consumption of imported oil through the use of homegrown alternative fuels that will help the state's economy and environment. DEP is seeking applications for innovative, advanced fuel and vehicle technology projects resulting in cleaner transportation within the commonwealth. DEP will consider projects in all of the categories listed below.

The (AFIG) Fund was established under Act 166 of 1992 and is administered by the DEP through the Bureau of Energy, Innovations and Technology Deployment.

We encourage you to read and review The Alternative Fuels Incentive Act of 2004, P.L. 1376, no.178, available at <a href="https://www.depweb.state.pa.us">www.depweb.state.pa.us</a>, keyword: "Alternative Fuels".

#### **General Eligibility**

In accordance with Act 178, reimbursement funding is available to the following entities and for the following types of projects:

- School districts, municipal authorities, political subdivisions, incorporated nonprofit entities, corporations, limited liability companies or partnerships incorporated or registered in the commonwealth for:
  - the retrofit of vehicles to operate on alternative fuels (fleet only see Definitions section below);
  - the incremental cost of the purchase of alternative fuel vehicles (fleet only see Definitions section below);
  - o the cost to install fleet refueling equipment for alternative fuel vehicles; and
  - next phase advanced research, development and training related to alternative fuels and alternative fuel vehicles.
- School districts, municipal authorities, political subdivisions and incorporated nonprofit
  entities for the incremental cost to purchase biofuel with or without the purchase of
  related refueling and storage equipment or tank cleaning.
- Qualified renewable fuel producers for the reimbursement of up to 10 cents per gallon of renewable fuels produced in a calendar year up to 12,500,000 gallons.

#### **Definitions**

The following are definitions of key terms that are used in this application package:

AFIG Grant – Monies allocated from the fund for a project approved by DEP.

American Society for Testing and Materials (ASTM) International – The nonprofit organization which develops consensus standards for materials, products, systems and services.

Biodiesel Fuel – Either of the following:

- A motor vehicle biofuel that is suitable for use in an internal combustion, compressionignition engine derived from vegetable oils or animal fats that is designated B100 and meets the ASTM specification D6751.
- Motor vehicle fuel blend suitable for use in an internal combustion, compression-ignition engine comprised of 5, 10, or 20 percent biodiesel blended with 95, 90, or 80 percent diesel fuel that is designated as B5, B10, or B20; respectively.

Biofuels – A motor vehicle fuel derived from alcohols, ether, esters and other chemicals made from cellulosic biomass such as herbaceous and woody plants, agricultural and forestry residues and a large portion of municipal solid and industrial waste.

Diesel fuel – A fuel that is commonly or commercially known, sold, or represented as diesel fuel, including any mixture of primarily liquid hydrocarbons that is sold or represented as suitable for use in an internal combustion, compression-ignition engine and meets the ASTM specification D975.

 Note that as of May 1, 2010, all on-road transportation diesel fuel sold in the Commonwealth of Pennsylvania must contain 2% biodiesel. Therefore B2 is now considered conventional diesel fuel in the commonwealth.

Department – The Department of Environmental Protection of the Commonwealth of Pennsylvania.

Ethanol – An alcohol primarily produced from corn in the U.S. that can be used as an alternative vehicle fuel. "Cellulosic" ethanol is made from a wide variety of plant materials or non-food based feedstocks, including agricultural wastes such as corn stover, forest wastes such as saw dust and forest thinnings and energy crops, such as switchgrass.

Fleet – For the purposes of this grant program and the applicable project types, a fleet is defined as a group of 10 or more vehicles, comprised of passenger cars, light-duty trucks, buses and heavy-duty trucks up to 26,000 pounds gross vehicle weight, that is owned and operated by a single entity located within the commonwealth.

Fund – The Alternative Fuels Incentive Fund.

Grantee - An applicant that has an executed AFIG grant agreement with DEP.

*Incremental cost* – Either of the following:

- The difference between the base price of conventional diesel fuel (B2) and biodiesel fuel blends of B5 or higher.
- The difference between E85 ethanol and conventional gasoline.
- The difference between the base price of a conventional model vehicle and its alternative fuel model.

Infrastructure – A permanent structure for transportation, storage or dispensing of alternative fuels. "Facilities" are buildings and other structures that involve new land development or result in a change to the existing use of land that may involve research, development, production and processing of alternative fuels, or manufacturing of alternative fuel vehicles and related technologies.

*Municipal Authority* – A body corporate and politic as defined by Section 5602 of the Municipality Authorities Act (53 Pa.C.S. §5602) or successor statutes.

Nonprofit Entity – Any association, as defined by Section 102 of the Associations Code, 15 Pa.C.S. §102, that is not organized for a purpose or purposes involving pecuniary profit, incidental or otherwise, to its shareholders or members, that is registered with the Pennsylvania Department of State's Bureau of Charitable Organizations, maintains 501(c)(3) status with the Internal Revenue Service, and is incorporated under the laws of Pennsylvania or has a certificate of authority from the Pennsylvania Department of State to conduct business in Pennsylvania.

Qualified Renewable Fuel Producer – A producer of a renewable fuel whose production facility is located within this commonwealth and produces a minimum of 100,000 gallons of biofuel annually for commercial sale.

#### **General Conditions**

The awarding of AFIG grants is subject to the following limitations and conditions:

- A single grantee cannot receive more than 10 percent of the funds available in any one funding year.
- The total dollar amount of awards to grantees operating within and including any county cannot exceed 15 percent of the funds available in any one funding year.
- DEP reserves the right to not award funds to applicants that have not completed projects previously funded with AFIG funds.
- Applicants must not have any outstanding obligations to the commonwealth and must not have any unresolved environmental violations.
- Applicants who have previously received grants and completed AFIG funded projects but have failed to submit the proper reporting forms may not be considered for funding.
- All projects must have a measurable environmental net benefit for the commonwealth.
- Written consent of property owners must grant DEP access to project sites.
- The activities funded must be conducted in Pennsylvania.
- Grantees must secure all permits or approvals otherwise required for the project to proceed.
- Grantees must comply with all commonwealth requirements in the implementation of the project.
- No project period of performance may begin before July 1, 2010. Your project may be as long as, but not to exceed, 24 months with an absolute end date of June 30, 2012.

#### **General Application Criteria**

Applications will be evaluated based solely on the data provided; therefore, completeness and accuracy are important. Applications that do not meet the requirements for the program will not be reviewed and are not eligible for funding.

- The application, project description and budget sheets must be complete and include: the project description and all items contained in the application instructions;
- The application must include documentation supporting the anticipated energy generation or fossil fuel displaced. Applicants must submit any applicable equipment specifications, maps, drawings or photos associated with the project.
- The application must contain letters supporting the financial commitment for any match claimed. These letters of commitment must be from both the applicant and any outside sources of funding, including clear documentation of amounts from each source.
  - o Monies "applied for" from other sources may not be included.
  - o Other DEP program funds cannot be used to comply with the project match.
- The application must include a spending plan for the project.
- AFIG funds <u>cannot be used</u> to cover the following costs:
  - Preparation of the AFIG application;
  - Land acquisition;
  - o Permits:
  - Landscaping;
  - Advertising;
  - Business start-up costs;
  - o Indirect costs (i.e., general administrative and overhead, contingency funds, etc.);
  - Travel, lodging, subsistence:
  - Conference or meeting expenses including catering, conference equipment and room rental; and
  - Any other cost not deemed acceptable to DEP.
- All projects must be consistent with the applicable provisions of the Keystone Principles for Growth, Investment, and Resource Conservation. A description of the Keystone Principles is available on the PEDA Web site, <a href="www.depweb.state.pa.us">www.depweb.state.pa.us</a> keyword "PEDA," or at <a href="www.phmc.state.pa.us/bhp/pkp.pdf">www.phmc.state.pa.us/bhp/pkp.pdf</a>.
- Building Permits:
  - o If building permits are required for the project and the applicant has received a permit, the applicant must include a copy of the permit with the application.
  - If a permit has not yet been received prior to the application, a copy of the permit must be supplied to the department prior to the first payment.

#### **General Application Recommendations**

AFIG strongly encourages participation by small disadvantaged businesses as prime contractors, joint ventures, and subcontractors/suppliers and by socially disadvantaged businesses as prime contractors. This recommendation refers to use of to the maximum extent possible, local Pennsylvania contractors, suppliers, products, services, labor, and minority and women-owned and disadvantaged business enterprises to successfully bring projects to fruition, greatly benefiting Pennsylvania's local communities and economy.

Small Disadvantaged Businesses are small businesses that are owned or controlled by a majority of persons, not limited to members of minority groups, who have been deprived of the opportunity to develop and maintain a competitive position in the economy because of social disadvantages. The term includes:

- Department of General Services Bureau of Minority and Women Business Opportunities (BMWBO)-certified minority business enterprises (MBEs) and women business enterprises (WBEs) that qualify as small businesses; and
- United States Small Business Administration certified 8(a) small disadvantaged business concerns.

- Applicants are strongly encouraged to contact the appropriate DEP staff to discuss the application before submittal. Contact information for DEP staff is included in this booklet on page 9.
- The use of Pennsylvania contractors, suppliers, labor and products is also strongly preferred.
- Applicants are encouraged to apply for eligible projects that create co-benefits for other renewable and alternative energy production projects within Pennsylvania.

#### **General Grant Award and Contract Conditions**

- 1. Projects selected for funding will receive a letter from the DEP Secretary or designee, addressed to the contact person specified in the application.
- 2. Grantees will be assigned a DEP project advisor and Grantees may be required to meet with DEP staff to review contract requirements.
- 3. After the announcement of a grant award, DEP will forward a grant agreement to the recipient. Grantees will be required to execute the grant agreement, including a detailed scope-of-work, project schedule, budget and other information.
- 4. Grantees that have not had previous contracts or grant agreements with the commonwealth will be required to obtain a vendor identification number through the Vendor Data Management Unit, <a href="https://www.vendorregistration.state.pa.us/cvmu/paper/GranteeRegistration.aspx">https://www.vendorregistration.state.pa.us/cvmu/paper/GranteeRegistration.aspx</a> (Non-Procurement Registration Link) and to submit a Form W-9, Request for Taxpayer Identification Number and Certification.

- 5. Project activities and payment requests may begin after the grantee and the commonwealth have signed the grant agreement.
- DEP will make payment to the successful grantee based on review of the required Application for Reimbursement form, accompanying invoices, and adequate proof of payment documentation. DEP will not fund costs in excess of the requested grant amount.
- 7. For biofuels incremental buy down grants, the following must also be submitted in order to secure reimbursement:
  - Invoice(s) documenting the following:
    - Gallons of biodiesel blended fuel or E85 purchased;
    - The price of the biodiesel blended fuel or E85. Supplier must show any federal tax credit pass through in the price of the fuel; and
    - The price of the diesel fuel or gasoline on the invoice date of delivery.
  - Documentation from the supplier that the biodiesel fuel delivered meets ASTM D6751 specification
  - Period of time (MM –DD -YY) covered by request for reimbursement
- 8. For biofuels incremental buy down grants, the actual amount of reimbursement may be less than the estimated amount indicated in the grant agreement due to amounts purchased or price paid. The specific terms of reimbursement for each participant will be contained in the grant agreement.
- 9. Grantees will be paid for funds expended only during the period of performance.
- 10. Reporting and Invoices:
  - The grantee must submit Monthly Report Forms for the duration of the grant period, a Final Report within 30 days of when the grant is completed, and a One-Year Follow-Up Report as detailed in the special conditions of the grant agreement.
  - Grantees must ensure current Monthly Report Forms are on file with DEP for the periods covered by each Application for Reimbursement, as outlined in the grant agreement.
  - The grantee will use the report forms provided by the DEP. These forms will be referenced in the grant agreement, but not attached to the grant agreement.
  - The grantee will be responsible for providing all the information required to complete the grant report.
  - Grantees will be required to submit a One-Year Follow-Up Report including performance measures and jobs created or retained one year after the project completion date.

#### 11. Completion of Project:

- The project must be completed as described in the grant document.
   Modifications to the project will not be considered, except for limited scope and budget changes approved by the department.
- Changes may include replacements of equal quality and function, and reallocation of contract budget category dollar amounts to and from other budget categories, as long as the maximum contract dollar amount payable by DEP to the recipient is not exceeded.

#### 12. Permits:

- Grantees must secure all permits or approvals otherwise required for the project to proceed. This includes any permits required by DEP.
- o If building permits are required for the project, copies of the permits shall be submitted prior to the first payment request. DEP will not make payments to the grantee prior to receiving a copy of the required permit. The final building inspection report must be signed, and a copy must be submitted to DEP, before the grantee applies for final payment.
- Grantees must comply with all applicable laws and local ordinances including local, commonwealth and federal requirements in the implementation of the project.
- 13. Grantees who claimed the use of a Small Disadvantaged Business certified by BMWBO as an MBE/WBE must provide a photocopy of their BMWBO certificate.
- 14. Accounting and Financial Controls:
  - Grantees must properly manage and account for funding received. A complete spending record for all expenditures will be required, including invoice receipts, logs of record and other properly certified documents.
  - Matching funds provided by the applicant must be spent during the period of performance. No credit will be given for funds spent prior to the period of performance. Matching funds must correspond to eligible categories as outlined in the project budget. Documentation will be required for matching funds as well as DEP funds.
  - All funding must be spent in accordance with the spending plan included in the grant agreement. DEP reserves the right to terminate the project and/or recover funding from grant recipients not properly managing the funding in accordance with the conditions of the program and the grant agreement.
  - If any other grant condition is not adhered to, DEP reserves the right to terminate the project and/or recover funding from grantees that are not properly managing the funding in accordance with the conditions of the program and the grant agreement.
  - Extensions will not be granted, unless the department concludes it to be necessary by determination or request.
  - Requests for extensions to the period of performance must be received sixty days prior to the end date of the period of performance on a DEP Change Scope, Change Budget, or Extension Request form. Change Scope, Change Budget, or Extension Request forms may be obtained from the grant project advisor.
  - DEP reserves the right to inspect projects financed with AFIG funds and to audit or require a third-party audit of any project's financial transactions or compliance with agreement terms.
  - AFIG grant proposals are public documents and subject to disclosure to the public upon request. Any information included in the grant proposal that the applicant wishes the commonwealth to consider as proprietary must be on a separate sheet of paper and must be clearly marked as proprietary.

- 15. Projects may be subject to Pennsylvania Prevailing Wage Act requirements.
  - Grantees shall insure where necessary that construction projects with a cost in excess of \$25,000, which are subject to Pennsylvania's Prevailing Wage Act requirements, are paid appropriate wages commensurate with the Act.
  - For information about the applicability of Prevailing Wage, applicants are encouraged to contact the Department of Labor and Industry at (717) 705-7256 or (800) 932-0665 or visit the Web site at www.dli.state.pa.us. It is solely the responsibility of a grantee to ensure the Act is followed if applicable.

Costs associated with a project to be reimbursed with AFIG cannot have been incurred **before** July 1, 2010. The Alternative Fuels Incentive Grant Program is a competitive program and an application may fail to receive funding or be determined unacceptable due to application inadequacies. **Any applicant who begins a project and incurs costs before receiving a fully executed grant agreement does so at his or her own risk.**

# Fleet Vehicle Purchases, Retrofits and Refueling Equipment for Alternative Fuel Vehicles

Eligibility and Evaluation Criteria

# Eligibility – Cost to Purchase, Retrofit and Install Fleet Refueling Equipment for Alternative Fuel Vehicles

School districts, municipal authorities, political subdivisions, incorporated nonprofit entities, corporations, limited liability companies or partnerships incorporated or registered in the commonwealth to retrofit fleet vehicles to operate on alternative fuels, the cost of the purchase of alternative fuel fleet vehicles and cost to install refueling equipment for alternative fuel fleet vehicles.

#### • Eligible applicants include:

- Businesses corporations, partnerships, sole proprietorships, limited liability companies, business trusts, or other legal business entities incorporated in the commonwealth
- Non-Profit Corporations Incorporated not-for-profit organizations that maintain 501(c)(3) status with the U.S. Internal Revenue Service and are also registered with the PA Bureau of Charitable Organizations
- School Districts
- o **Political Subdivisions** A Pennsylvania municipality or county
- Municipal Authorities

#### • Eligible projects include, but are not limited to:

- Fleet purchases of CNG Transit Authority Buses, Refuse Trucks and CNG Refueling Stations;
- Fleet conversion of trucks to propane vehicles;
- o Fleet purchase of hybrid electric vehicles (HEVs); and
- Fleet electrification of airport ground service equipment (GSE) and chargers.

#### Projects that are not eligible include:

- Projects already completed prior to submitting an application to DEP;
- Projects located outside of Pennsylvania;
- Projects that are solely feasibility studies; and
- o Projects that only convert from one alternative fuel to another alternative fuel.

#### • Projects must comply with the following in order to be funded:

- o All projects must be physically located in Pennsylvania.
- No project proposal may exceed \$1 million.
- Projects must have match cost share.
- Only the incremental cost difference between the conventional and AFV model will be funded for purchases.
- Applies to Fleet only:
  - For the purposes of this grant program and the applicable project types, a fleet is defined as a group of 10 or more vehicles, comprised of passenger cars, light-duty trucks, buses and heavy-duty trucks up to 26,000 pounds gross vehicle weight that is owned and operated by a single entity located within the commonwealth.

- The number of fleet alternative fuel vehicles purchased or converted must be a minimum of two vehicles.
  - A non-profit political subdivision may aggregate vehicles from two or more, smaller local governments within its jurisdiction to meet the minimum number (10) of vehicles required for fleet eligibility.
- DEP will limit reimbursement for consultant costs to a maximum of 5 percent of the total eligible project costs less the cost of the consultant.

#### AFIG funds cannot be used to cover the following costs:

- Preparation of the AFIG application;
- Land acquisition;
- o Permits:
- Landscaping;
- Advertising;
- Business start-up costs;
- o Indirect costs (i.e., general administrative and overhead, contingency funds, etc.);
- o Travel, lodging, subsistence;
- Conference or meeting expenses including catering, conference equipment and room rental; and
- Any other cost not deemed acceptable to DEP.

#### **Application Evaluation**

DEP will conduct a comprehensive review of the grant applications and supporting documentation (i.e., cost estimates). DEP will not accept and will not review an application that is incomplete or contains inaccurate information. All complete applications will be reviewed and evaluated by the DEP using the criteria defined below.

#### **Evaluation Considerations**

- Technical feasibility; proven proposed technology;
- Whether the applicant has demonstrated that it can carry out the proposal;
- Financial feasibility;
- Environmental benefits, avoided emissions;
- Potential to reduce conventional energy consumption or increase energy production from alternative energy sources;
- Number of vehicles;
- Likely creation or retention of jobs;
- Promotion of Pennsylvania's indigenous energy resources;
- Promotion of Pennsylvania's energy diversity and security;
- Encouragement of alternative energy production and use;

- Economic benefits for the commonwealth, including savings to consumers and/or revenue generation for other beneficiaries such as farmers or other landowners;
- Quality and relevance of the research and next phase technology demonstration, if applicable;
- Whether the project is consistent with the Keystone Principles. A description of the Keystone Principles is available on the PEDA Web site, <a href="www.depweb.state.pa.us">www.depweb.state.pa.us</a> keyword "PEDA," or at: <a href="www.phmc.state.pa.us/bhp/pkp.pdf">www.phmc.state.pa.us/bhp/pkp.pdf</a>);

- Political Subdivisions A Pennsylvania municipality or county

#### Eligible Innovative Technology projects include, but are not limited to:

- o Research, development and testing of advanced fuel cell engines;
- Installation and demonstration of new methanol recovery equipment in biodiesel production;
- Development and testing of advanced electric drive controllers, batteries and components;
- Demonstration of conversion of waste coal into liquid fuels;
- o Research, development and testing of advanced catalysts, enzymes or fuels; and
- Production and extraction of biogas (methane) from waste for use in transportation vehicles.

#### • Projects that are <u>not</u> eligible include:

- Projects supporting the building or deployment of a conventional biofuel or alternative fuels production facility will not be considered under this grant category. # Incremental Cost to Purchase Biofuels with Equipment Purchase or Tank Cleaning and without Equipment Purchase or Tank Cleaning

Eligibility and Evaluation Criteria

# Eligibility – Incremental Cost to Purchase Biofuels with Equipment Purchase or Tank Cleaning and without Equipment Purchase or Tank Cleaning

School districts, municipal authorities, political subdivisions and incorporated nonprofit entities for the incremental cost to purchase biofuel with or without the purchase of related refueling and storage equipment or tank cleaning

#### Eligible applicants include:

- Non-Profit Corporations Incorporated not-for-profit organizations that maintain 501(c)(3) status with the U.S. Internal Revenue Service and are also registered with the PA Bureau of Charitable Organizations
- School Districts
- o **Political Subdivisions** A Pennsylvania municipality or county
- Municipal Authorities

#### Eligible projects include:

- Purchase of biodiesel or E85
  - Example: School District A purchases 3,000 gallons of B20 or E85 and takes delivery of the B20 or E85 on Jan 1, 2008. On the day of the alternative fuel delivery, the price of the conventional fuel (diesel or gasoline) was \$3.00 per gallon. The price for the alternative fuel for the same date was \$3.11 per gallon, with an upcharge of \$.15 per gallon, for a total price of \$3.26 per gallon. The incremental cost to School District A of purchasing the alternative fuel in lieu of diesel or gasoline is (\$3.26 \$3.00) = \$.26 per gallon. Total reimbursement for this delivery is (3000 gallons) X (\$.26/gallon) = \$780.
- Costs associated with the cleaning of existing fuel storage tanks to make them useable as storage for biodiesel or E85
- The purchase price and associated costs for the equipment necessary to store fuel and refuel vehicles that operate on biodiesel or E85
- The costs associated with the design, site preparation and construction of refueling or storage equipment

#### Projects that are not eligible include:

- o Projects already completed prior to submitting an application to DEP;
- Proiects locate outside Pennsylvania:
- o Projects that are solely feasibility studies; and
- Projects that convert from one alternative fuel to another.

#### Projects must comply with the following in order to be funded:

- All projects must be physically located in Pennsylvania;
- No project proposal may exceed \$1 million;
- Refueling and storage equipment must be owned and operated by an entity who
  is an eligible applicant;
- Refueling and storage equipment must be located in Pennsylvania;
- The entity must be committed to using the equipment for dispensing biodiesel or E85 for the entire grant period;

- Biodiesel must be purchased as a transportation fuel and must be biodiesel blends that range from a blend of 5 percent biodiesel and 95 percent diesel (B5) to a blend of 20 percent biodiesel and 80 percent diesel (B20). A B2 blend is not eligible for funding;
- Biodiesel used in all blends must meet the ASTM D6751 specification;
- Ethanol must be used as a blend of 85 percent ethanol with 15 percent gasoline (E85);
- The applicant must supply the incremental cost difference between the base price of conventional diesel and biodiesel blended diesel fuel, or the incremental cost difference between conventional gasoline and E85; and
- o Projects with equipment must have match cost share.

#### **Application Evaluation**

DEP will conduct a comprehensive review of the grant applications and supporting documentation (i.e., cost estimates). DEP will not accept and will not review an application that is incomplete or contains inaccurate information. All complete applications will be reviewed and evaluated by the DEP using the criteria defined below.

# **Reimbursement for Biofuel Production**

Eligibility and Evaluation Criteria

#### Eligibility – Reimbursement for Biofuel Production

Qualified renewable fuel producers for the reimbursement of up to 10 cents per gallon of renewable fuels produced in a calendar year up to 12,500,000 gallons.

Note: This reimbursement is for ethanol and for smaller producers of biodiesel that may not qualify for the Biomass-Based Diesel Production Incentive, the production incentive of \$0.75 per gallon as per Section 3.1 (a)(2)(B) of the Act of November 292004 (P.L. 1376, No. 178).

#### Eligible applicants include:

- Qualified Pennsylvania producers whose production facilities of alternative fuel are located within the Commonwealth of Pennsylvania.
- Qualified biodiesel or ethanol production facility that produces a minimum of 100,000 gallons annually for commercial sale.

#### Eligible projects include:

 Reimbursement of up to 10 cents for every gallon of biodiesel or ethanol produced by the applicant for use as an alternative transportation fuel.

#### Projects that are not eligible include:

Projects that only convert from one alternative fuel to another alternative fuel

#### • Projects must comply with the following in order to be funded:

- o All projects must be physically located in Pennsylvania.
- o The maximum number of gallons eligible for reimbursement for a single qualifying producer in a calendar year is 12,500,000 gallons.
- The applicant may only request reimbursement for the production of biodiesel or ethanol used as a transportation fuel covering the grant period of performance.
- The biodiesel transesterification process must occur in Pennsylvania. Any volume of biodiesel fuel transesterified outside the commonwealth that is added to augment the in-state produced volume does not qualify as Pennsylvaniaproduced fuel.
- A qualifying producer must submit a "certificate of analysis" from an accredited laboratory for every 500,000 gallons of biodiesel produced as evidence that the biodiesel meets the ASTM D6751 standard.
- A "certificate of analysis" for reduced specification testing according to the following schedule must be submitted for each interim 100,000 gallons produced.

#### **Biomass-Based Diesel Production Incentive**

- o Biodiesel facilities located within the commonwealth that produce a minimum of 25,000 gallons of biodiesel per month may participate in a Biomass-Based Biodiesel Production Incentive. This incentive reimburses producers at the rate of 75 cents per gallon for neat biodiesel sold to a qualified Pennsylvania buyer. There is a maximum incentive of \$1.9 million per producer and a program total maximum of \$5.3 million ending June 30, 2011.
- A qualifying biodiesel producer that has been awarded a 10 cents per gallon AFIG grant may participate in either the 10 cents per gallon AFIG grant or the 75 cents per gallon Biomass-Based Biodiesel Production Incentive, but not participate in both programs.
