DEP has been working over the past 5 years to transition all records to a unified Electronic Records Management System (ERMS).


A major feature of this system is the ability for the public to provide documents directly to DEP through a Public Upload interface. You may have encountered this public upload system in the past.

The system has been recently integrated with a payment function that can be used by many areas in DEP to accept electronic payments. This function would be unusual for most Storage Tanks document submissions. The payment feature can be used for Site-Specific Installation Permit (SSIP) payments and penalty payments associated with enforcement documents.

ePermitting Submissions

DEP's e-permitting system for electronic submission is strongly recommended and is DEP's preferred submission method. The system is designed to ensure that applicants submit the required information at the time of submission, which reduces errors, and provides the most efficient fastest review timeframes for permit authorizations available in e-permitting.

Public Upload with Electronic Payment

DEP accepts permit and authorization applications as well as many other documents via <u>public upload</u> including electronic payments, if applicable. While this submission process is not as efficient as using e-permitting, it provides a much more efficient option than printing and mailing applications with paper checks.



 - This is NOT intended to allow submitters to send in documents for multiple facilities or document types in the same upload.



- When Can I Submit Multiple Documents?
 - UST Example:
 - Modification Report: May also attach testing forms and facility diagram.
 - FOI Report: Should also attached Cathodic Protection Evaluations reviewed during the inspection. May also attach monthly walkthrough inspections, 60-day ICCP rectified readings, and other documents reviewed to make compliance determinations in the course of the inspection.



- When Can I Submit Multiple Documents?
 - AST Example:
 - Inspection Report (General): May attach supplemental documentation related to the ONE tank system being inspected (ex: P.E. Containment Certification).
 - OS Inspections: May attach the Lining Inspection Form where required.
 - Modifications and Modification Inspections: May attach supplemental documentation related to the reported activity.



- When Can I Submit Multiple Documents?
 - Registration Example:
 - Registration/Permitting Applications: May also attach UST Operator training documentation, deed (or other ownership documentation), substance SDS, or other pertinent documentation relating to the registration submission.
 - Certification Example:
 - Certification Applications: May attach the Attachment A, training course certificates, manufacturer letters, or other documentation associated with the submitted application.

- <u>Clear Confirmations</u> certified individuals and companies are provided with a clear submission confirmation to verify timely and appropriate submission.
- <u>Single Submission</u> no need to send to multiple email addresses and verify submission to the correct regional office resource email account.
