Location: From downtown Pittsburgh take I-376 toward PIA. Exit 56

McClaren Road. Turn Left and proceed 1.3 miles and continue onto Main Street for 1.5 miles. Turn slight right on U.S. 30 west. Take 2nd right onto Cummings Road (Gate QQQ). Continue 0.8 miles and turn left onto Imperial Road for 0.4 miles to site.

<u>Purpose:</u> Accelerated response project to isolate burning mine spoils from

the combustible spoil fill where a Pittsburgh International Airport (PIA) radar tower facility is located and a nearby gas pipeline is buried. A firebreak and extended isolation trench were excavated and have contained the fire until the full excavation and extinguishment project design is completed, bid and constructed.

Description:

The accelerated response project cleared a firebreak and extended an isolation trench originally constructed by an OSM Emergency Project. The spoil fire required constant maintenance, had periodically ignited vegetation, and emits noxious gasses and steam, impacting area visibility and endangering radar facilities, a gas pipeline, and forest resources. Design of the full extinguishment project is scheduled to be completed in October 2013 under Contract No. OSM 02(0351)102.1. Construction is anticipated to commence in January 2014.

Funding:

The project was financed through a Federal Abandoned Mine Land Grant funded by the coal industry via fees paid on each ton of coal mined.


