

#### FACT SHEET


Location:	The fire was located in a large coal refuse bank approximately 300 feet north east of Oak Street in Archbald Borough Lackawanna County. The center of the mine fire was located at North Latitude 41° 30' 23.8", West Longitude 75° 34' 4.4" on the Carbondale, 7.5 minute, U.S.G.S. Topographic Quadrangle Map.

Project Area:	3.3 acres
Purpose:	The intent and scope of this project was to eliminate an imminent public health and safety hazard by extinguishing a coal refuse fire.
<u>Description:</u>	The surface expression area of the fire measured approximately 35 feet in diameter with the depth being unknown. Smoke and odor were affecting nearby residents. The height of the refuse bank was estimated to be 30 to 40 feet high. The bank covered approximately 1.7 acres and sat on the east side of a much larger coal refuse area that covered approximately 20 acres. It was evident the site was frequently visited by unauthorized recreational vehicles. Six homes were located within forty to sixty feet of the project site. Mining was conducted within the Raymond Colliery in this area of Archbald Borough and was last mined in 1947.

The project consisted of establishing a water supply, excavating the burning refuse, quenching the fire and grading the surrounding area. It was necessary to

excavate 32,856 cubic yards of material, transport 1,110,000 gallons of water to<br/>the site via water tankers, and 1,170 gallons of Class A Fire Fighting Foam was<br/>used to extinguish the refuse fire.
