**Location:** The site of the work that was performed under this contract is

located in Foster Township, Luzerne County, approximately 7,000

feet north of the SR940/SR2049 intersection in Freeland.

Watershed: Oley Creek, Cold Water Fishes (CWF)

**Project Area:** 63 acres

**Purpose:** Eliminated public health and safety hazards by backfilling a strip

pit and grading dangerous piles and embankments. Additionally, the project work reduced a significant erosion problem that affects

a stream which feeds Beech Mountain Lake.

**Description:** The site is located within the eastern middle Anthracite Coal Field

and the last mining in the area was of the Upper Lehigh mine veins

prior to 1963. The site included 3 dangerous piles and

embankments, 1 stripping pit, and 1 spoil pile and is frequently used by unauthorized recreational vehicles that access the site by way of the commonly used Birkbeck Street. The project consisted of backfilling the stripping pit and grading the piles. An unnamed tributary to Oley Creek conveyed a large amount of sediment from the site and into Beech Mountain Lake. In order to eliminate the hazards and reduce the erosion problem, 1,053,680 cubic yards of on-site material was re-graded over the 63 acre area. Rock and grass lined channels were constructed to convey storm water runoff. The site was then stabilized with a grass and legume seed

mixture.


