SPACING ORDER NO. 9

HISTORY OF THE CASE

1. January 19, 1970, an application was received in the office of the Oil and Gas Conservation Commission, Department of Mines and Mineral Industries, filed by Felmont Oil Corporation and Consolidated Gas Supply Corporation for a spacing order in the Pineton Oriskany Gas Pool, Pine and Green Townships, Indiana County, and Barr and Susquehanna Townships, Cambria County, Pennsylvania, for approval of drilling units in said pool, and for integration of royalty interests in the respective units proposed to be established.
2. January 30, 1970, notification was sent by certified mail to those parties known to be interested in the area proposed to be spaced and by regular mail to others who had indicated to the Commission that they wished to be notified of any Hearings that may affect lands in the area that a Hearing would be held Monday, February 16, 1970, at 1:30 P. M., Eastern Standard Time, in the Public Utility Commission Hearing Room, 12th Floor, State Office Building, Pittsburgh, Pennsylvania, to consider the application.

3. January 31, 1970, notification of said Hearing was published in the Johnstown Tribune Democrat, Johnstown, Pennsylvania, and in the Indiana Evening Gazette, Indiana, Pennsylvania, daily newspapers in general circulation in Cambria and Indiana Counties, respectively. The same notification was published February 7, 1970, in the same newspapers.
4. February 11, 1970, request was received by letter of February 7, 1970, from Leroy F. Perry, Attorney for Applicants, that the subject application be withdrawn and that it be replaced by an application enclosed with said letter.
5. February 13, 1970, notice of the cancellation of the hearing for Spacing Order Docket No. 9, together with notice of the scheduling of the Hearing concerning Spacing Order Docket No. 10, was mailed to those who had originally been notified of the proposed Hearing. Said notice of cancellation and the scheduling of Hearing for Spacing Order Docket No. 10 was published February 14, 1970, in the Johnstown Tribune Democrate, Johnstown, Pennsylvania, and in the Indiana Evening Gazette, Indiana, Pennsylvania.

ORDER

Accordingly, the Commission does order that:

Due to the desire of Applicants, as per their counsel's letter of February 7, 1970, that the application concerning Spacing Order Docket No. 9 be withdrawn, the Hearing is hereby cancelled and the docket concerning Spacing Order No. 9 is hereby cleared, without prejudice.
