Agency Consultation/Coordination: The results of the archaeological, geomorphological and Architectural History investigations conducted in Schuylkill County have been submitted to the PHMC for review, as parts of four report packages: the March 2015 Initial Report Package, the November 2015 Addendum 1 Report Package, the May 2016 Addendum 2 Report Package, and the August 2016 Addendum 3 Report Package. These report submittals are marked "Contains Privileged Information – Do Not Release," and can be available upon request directly to the PHMC. The PHMC has not requested any other specific survey methodologies or data with regard to the Project elements in Schuylkill County, aside from that supplied in the following reports and PHMC correspondence (Table D-1) and copies of these clearance/approval letters are provided within Attachment D-2.

The Unanticipated Discovery Plan prepared for the Project was included as part of the March 2015 Phase I report submittal, and approved for use by the PHMC in the 21 September 2015 response letter (noted above). The Unanticipated Cultural and Human Remains Discovery Plans and the Unanticipated Discovery Plan for Paleontological Resources Plan are included as Attachments 4 and 5, respectively, within the ECP (Attachment M).

Public Outreach: An open house for the Project in Schuylkill County was held at Tremont Fire Co. No.1, on June 9, 2014. Public comment from several landowners was received on potential cultural issues, all of which were examined and addressed during the cultural resources field reconnaissance for the Project. In addition to the open house, consultation was initiated with the Historical Society of Schuylkill County, Mahanoy & Mahantongo Historical & Preservation Society, and Pine Grove Historical Society concerning cultural resources in Schuylkill County. The Historical Society of Schuylkill County had no comment on the Project. No response to consultation requests were received from Mahanoy & Mahantongo Historical & Preservation Society or Pine Grove Historical Society.

Consultation was also initiated with 25 Native American tribal entities that may have cultural resources concerns within Schuylkill County. Of the 25 tribes contacted, the Catawba Indian Tribe, Delaware Nation, Delaware Tribe of Indians, Oneida Nation, and the Stockbridge Munsee Band of Mohicans requested Project cultural resources documentation and provided comment on the Project. Cultural resources documentation has been provided, and coordination is ongoing with these five tribal entities.

Cultural Resources Survey Summary: The Phase I archaeological field reconnaissance conducted in Schuylkill County examined accessible portions of the 18.2 miles of proposed CPL-South alignment, through investigation of a 300-foot-wide study corridor and full survey coverage of ancillary work areas. This survey involved the examination of 6,512 sample loci, with 1,619 occurring on steep slopes, 210 SL as wet (in either a waterbody or wetland), 820 SL within agricultural fields displaying sufficient ground surface visibility to meet PHMC guidelines, and 2,232 SL were determined to have been subjected to modern ground disturbance (most commonly underground pipeline utilities). The field crew also visually inspected 88 SL across residential properties. The visual inspection was supplemented by the hand excavation of 1,543 shovel tests. These investigations resulted in the identification of four archaeological resources within the current limits of the field survey, as outlined in the section below.

The Architectural History field reconnaissance of the Project elements in Schuylkill County resulted in the identification of 26 historic-era aboveground resources located within the viewshed of the Project, as indicated in **Table D-3**. An additional six aboveground resources were identified during field reconnaissance, on work areas subsequently removed from consideration as Project land requirements.

The geomorphological desktop study identified the Upper Mahantango Creek crossing as an area of increased potential for encountering deeply buried cultural deposits, and recommended field examination. However, Phase I shovel testing at this location determined further deep testing was not warranted and no additional geomorphological investigations were necessary.

Cultural resources fieldwork is projected in Schuylkill County during the summer and fall of 2016, on realigned and previously-inaccessible tracts of the CPL-South loop and additional temporary-use work areas.

Cultural Resources Identified: The Phase I archaeological field reconnaissance of Schuylkill County resulted in the identification of four archaeological resources. These resources represent low-frequency/ephemeral surface and plowzone artifact scatters, and one demolished structure representing a historic homestead, all displaying limited potential for intact, significant archaeological deposits. These resources were recommended as Not Eligible for the NRHP. **Table D-2** lists the archaeological resources identified in Schuylkill County.

A total of 32 aboveground resources were identified during the Architectural History survey conducted for Project land requirements in Schuylkill County; 26 of these resources are currently located within the Project, while an additional six resources were identified on parcels subsequently removed from the Project APE (due primarily to changes in the Project alignment). One of these resources was recommended as Eligible for the NRHP and additional documentation was requested by the PHMC. The Potentially Eligible resource was found to be Eligible by PHMC, and PHMC determined there would be no adverse effect on the resource from the Project. PHMC also determined there were no anticipated

effects to the remaining 25 resources as a result of the Project. **Table D-3** lists the inventory of aboveground resources identified in Schuylkill County.
