Dear Mr. Rocco:

On November 16, 2021 Sunoco Pipeline, L.P. (SPLP) submitted a Partial Notice of Termination (NOT) in accordance with 25 Pa. Code §102.7 to the Department of Environmental Protection (Department) for the referenced Chapter 102 permit. The Partial NOT was for areas of the project that SPLP determined to be permanently stabilized in accordance with 25 Pa. Code §102.7. This submission corresponded to the renewal application submitted on October 28, 2021 which covered those areas of the project not meeting the permanent stabilization requirements.

Since those submissions, SPLP has continued to coordinate with the County Conservation Districts (CCDs) and the Department for their concurrence on which areas meet permanent stabilization requirements and those that do not. As a result of this ongoing review, it is necessary to update the previous NOT submittal. Accordingly, as SPLP was directed by the Department, SPLP hereby requests to withdraw the November 16, 2021 Partial NOT submittal and intends to submit an updated Partial NOT package along with revised permit renewal submission.
