The DEPARTMENT OF ENVIRONMENTAL PROTECTION (DEP) and the County Conservation Districts have reviewed the above referenced application for completeness. The completeness review is the first step in a series of reviews conducted by DEP and the DISTRICTs.

The DEP and the DISTRICTs have determined that the application package contains sufficient detail to enable DEP and the DISTRICTs to conduct the technical review, and has been accepted for that purpose.

There is one issue that needs to be corrected before the permit is authorized and that is the PNDI must have all responses from the correct agencies as indicated on the PNDI.

This is not a final action by the DEP and the DISTRICTs on this application. The completeness review is the first in a series of reviews conducted by DEP and the DISTRICTs. The application will now move to the technical review stage of the permit review process. During the technical review, the adequacy of the application and its components will be evaluated to determine if sufficient information exists to render a decision on the technical merits of the application, as submitted.
