Floodplain/Stormwater Management Program Consistency Request**

Dear Supervisors:

On behalf of Sunoco Pipeline, L.P. (SPLP), Tetra Tech is sending this correction letter to follow-up the initial Floodplain/Stormwater Consistency Request we sent to Chartier's Township on December 22, 2015 regarding the Pennsylvania Pipeline Project (Project). This correction letter is to indicate that Tetra Tech has identified one (1) proposed aboveground facility within a Federal Emergency Management Agency (FEMA) designated Zone A (100-year floodplain) within Chartier's Township, identified as the Houston Injection Station. It is our understanding that Chartiers Township has been made aware of this proposed station and its location within a FEMA 100- year floodplain.

SPLP has minimized project impacts to the maximum extent feasible, including siting valves and permanent access roads out of waters and floodways of the Commonwealth. In Washington County, all permanent above ground facilities are located outside of wetlands, streams, FEMA floodways, FEMA floodplains, and DEP floodways, except the Houston Injection Station which is sited within the FEMA 100-year floodplain.

As requested by the Township and as required by Chapter 105 Water Obstruction and Encroachment Permit Joint Permit Application, a detailed floodplain analysis was performed to quantify the Project's effect on the base flood elevations (BFE) of Chartiers Run and Westland Run. The study was submitted to Chartier's Township for review, with comments received from Nichols & Slagle Engineering, Inc. We understand that the study is in review and request that you use it as needed to help with your consistency determination that we have requested.
