Floodplain Management and Stormwater Management Consistency Review

Dear Ms. Batoon:

A review of the above referenced project maps has been made. We recommend that the following comments be appropriately addressed before we recommend that the Hempfield Township Supervisors provide floodplain management consistency and stormwater and land disturbance activity consistency letters for this project.

1. Erosion and Sedimentation Control (E&SC) Plans and accompanying E&SC report for the portion of the pipeline project through Hempfield Township should be submitted in order for us to complete our review to determine the plan's consistency with the Township's Floodplain Management Ordinance and Stormwater Management and Land Disturbance Activity Ordinance.
2. Please note that prior to commencement of any land disturbance activities within Hempfield Township, a land disturbance application needs to be completed and submitted to the Township along with the appropriate application fee.
3. As per §49-28.F of the Township's Flood Damage Prevention Ordinance, any materials that are stored within the 100-year floodplain that are buoyant, flammable, explosive or potentially injurious shall be stored at an elevation of at least two feet above the regulatory flood elevation and/or floodproofed to the maximum extent possible.

Our office reviews Stormwater Management and Land Disturbance Plan applications solely to determine compliance with the Hempfield Township Stormwater Management and Land Disturbance Activity Ordinance as well as other relevant Township ordinances. Property and right-of-way owners are ultimately responsible for storm water leaving their site.
