Dear Mr. Siler:

Per your request, attached are the Erosion and Sediment Control Report and Plans, Land Disturbance application, and review fee for the Pennsylvania Pipeline Project within Hempfield Township. There are no permanent stormwater BMPs or impervious areas proposed within Hempfield Township.

#### Comments

1. **Comment:** Erosion and Sedimentation Control (E&SC) Plans and accompanying E&SC report for the portion of the pipeline project through Hempfield Township should be submitted in order for us to complete our review to determine the plan's consistency with the Township's Floodplain Management Ordinance and Stormwater Management and Land Disturbance Activity Ordinance.

**Response: The report and plans are attached for your review. Note the E&S plan sheets are Attachment 2 of the E&S report.**

2. **Comment:** Please note that prior to commencement of any land disturbance activities within Hempfield Township, a land disturbance application needs to be completed and submitted to the Township along with the appropriate application fee.

**Response: A Land Disturbance application and Fee are attached.**

3. **Comment:** As per §49-28.F of the Township's Flood Damage Prevention Ordinance, any materials that are stored within the 100-year floodplain that are buoyant, flammable, explosive or potentially injurious shall be stored at an elevation of at least two feet above the regulatory flood elevation and/or floodproofed to the maximum extent possible.

**Response: Response: Sunoco is currently in the process of obtaining Chapter 102 (Erosion and Sediment control) and Chapter 105 (Water Obstruction-Encroachment Joint permit) from the PADEP. Per the PADEP Erosion and Sediment Pollution Control Program Manual (March 2012), Hazardous or pollutant material storage areas shall be located at least 100 feet back from the top of streambank. In addition, as part of the Chapter 102 ESCGP-2 permit, a Preparedness, Prevention, and Contingency (PPC) Plan has been prepared and will be implemented during construction. The PPC plan outlines detailed pre-release planning steps to prevent an accidental spill or other incident.**
