The meeting of the Agricultural Advisory Board (Board) was called to order by Chris Uhland at 9:10 a.m.

Members of the Board introduced themselves, as did the other meeting attendees.

**Meeting Minutes** – The meeting minutes for the previous two meeting were approved. JV Lamb made the motion and it was seconded by Kerry Golden.

**Legislative Update** – Kerry Golden brought to the groups attention two bills. One bill is HB790, the Noxious Weed Bill and HB1486 the High Tunnel Stormwater Exception Bill.

**Chapter 102 Erosion and Sediment Control and NPDES Permits** – Lee McDonnell gave the group a general overview of some of the challenges of the Chapter 102 Program. DEP held 7 listening sessions in the first quarter of 2017 with stakeholders. Questions asked of the stakeholders included what is working well and what is not working well in the program. In addition, DEP solicited recommendations on program improvement. DEP is exploring how to implement that list of recommendations. The top recommendation of the listening sessions was a small project or low impact General Permit.

**Chapters 91/92a Fee Package Update** – Lee McDonnell gave the group an update on DEP's draft proposed rulemaking to raise fees for Water Quality Management and National Pollutant Discharge Elimination System permits. When DEP first presented this fee package to the Board, there was a five- and ten-year rollout plan to increase the fees. However, due to new budget analysis, DEP determined that it must raise the fees as soon as the rulemaking package is published as final. The NPDES CAFO program currently costs DEP more to administer that the fees it collects. Farm Bureau expressed opposition to a fee increase on CAFO's.

**Update on DEP Ag Inspection Initiative** – Doug Goodlander give the group an update on the status of the Initiative.

# Updates to Regulatory, Technical Guidance and Advisory Committee Policies -

Hayley Jeffords informed the Board that the Policy Office was now accepting comments on three revised policies. There is an open comment period that is the first step in the effort to enhance public engagement with DEP. The policies are available online on DEP's eComment website and interested parties may provide comments to DEP through Wednesday, December 13.
