Mr. Swanderski called the conference call meeting of the State Board for Certification of Water and Wastewater System Operators (Board) to order at 10:03 AM.

Criminal History Report

There were no criminal history reports to present to the Board.

Approval of August 18, 2016 Minutes

Mr. Kyle motioned to approve the August 18, 2016 minutes as written. Ms. Roland seconded the motion. The vote was unanimous. Motion carried.

Approval of New and Upgrade Applications

The new and upgrade applications were presented to the Board for approval. Ms. Roland motioned to issue licenses for all new and upgrade applications. Mr. Steffy seconded the motion. The vote was unanimous. Motion carried.

Reciprocity Requests

Four water and four wastewater reciprocity applications were presented to the Board for approval. Ms. Roland motioned to approve the reciprocity applications as presented. Mr. Swanderski seconded the motion. The vote was unanimous. Motion carried.

Board Secretary Report

Ms. Sansoni presented the following extension requests:

<u>Rick Baeshore—</u>is requesting an extension of his water and wastewater certifications. His WA 7, 8, 12 water certification renewal cycle expired September 30, 2014. He completed 16.5 hours of the required 30 hours of continuing education. His WWCE 1-4 wastewater certification renewal cycle expired June 30, 2016. He completed 0 training hours of the required 30 training hours to renew. He is requesting an extension due to health related circumstances. Ms. Roland motioned to grant the extension for both water and wastewater certifications until March 31, 2017. Mr. Steffy seconded the motion. The vote was unanimous. Motion carried.

<u>Walter Mattson</u>—is requesting an extension of his WAE 7-14 water certification which expired September 30, 2016. He completed 29.5 hours of the required 30 training hours to renew. He is requesting an extension due to health related circumstances. Mr. Swanderski motioned to extend the renewal cycle until March 31, 2017. Mr. Kyle seconded the motion. The vote was unanimous. Motion carried.

<u>Stephen Pletchan</u>—is requesting an extension of his WWAE 1-4 wastewater certification which expired March 31, 2015. He completed his required 15 hours of training but did not take the required security training. He is requesting an extension due to military deployment. Mr. Steffy motioned to extend the renewal cycle until December 31, 2016. Ms. Roland seconded the motion. The vote was unanimous. Motion carried.

A copy of the Barry Bracken Consent Order and Agreement was provided to Board Members for informational purposes. Mr. Bracken was charged with violations under the Clean Streams Law, the Water and Wastewater Systems Operators' Certification Act, and the Safe Drinking Water Act and Regulations.

Mr. Digilarmo discussed operator training and suggested the Board require operators to take some training that is relevant to the subclasses on their operator certificate to further their knowledge of Operations.
