Water budget screening for identification of critical water planning areas
March 2007-June 2009

Where we are

- We've completed two pilot screenings- Codorus Creek and Wissahickon.
- From the pilots we have confirmed a screening process and working on a draft report template.

Where we want to be- short term

- By end of August 2007, we are aiming to have at least 22 watersheds screened at an existing conditions level – Inclusion in initial Plan

Where we want to be- long term

- By end of June 2009, complete screening on additional priority watersheds at existing conditions and projected demand levels as funding permits.

Work Plan Elements

- Who- team effort of DEP, USGS, DRBC, SRBC and ICPRB.
- What- Screening of 4 watersheds in each of 5 basins with two in Great Lakes
- When-Work will begin this month
- How- DRBC does screening in Delaware, ICPRB does Potomac, USGS does Ohio and Great Lakes, DEP project managers and performs initial projection work.

Initial Screenings


- Selection of 22 watersheds based on:

 - ◆ Input from river basin commissions
 - ◆ Input from regional offices/ DEP reps on the regional committees
