Administrative Items

- 1. The summary from the previous meeting held on February 18, 2003 was approved with the following corrections:
 - 1. The last paragraph under the DRBC section should read: "To help the regional committees accomplish their tasks with the State Water Plan, DRBC can provide technical support and data information with existing resources; USGS study

- results such as water budgets and groundwater estimates; and progress reports in the DRBC Basinwide Operating Plan Water Resources Plan for the Delaware River Basin."
- 2. Under the Wrap-Up/Next Steps section, add: "Kate Harper requested that a summary of water quality laws be given at a future meeting."

- 2. John Hines announced that the Statewide Committee members have all been appointed and that the first meeting of the committee is Monday, May 10.
- 3. DEP staff proposed that an outreach ad hoc workgroup be formed consisting of regional and statewide committee members and DEP staff. If all regional committees are in agreement, the workgroup will meet to develop an outreach strategy and framework that is consistent among all of the regional committees. The workgroup members will be contacted about a meeting of the large ad hoc workgroup that DEP staff hope to set up in late May.
- 4. Dave Jostenski and Sue Weaver provided an update on the Act 220 registration process. Registration information will be used to develop an inventory of water use data. A water budgeting model will utilize the water use registration information to assess the availability of water and identify critical areas. All public water supply agencies, hydropower facilities and all users exceeding an average rate of 10,000 gallons per day in a 30-day period must register. Approximately 2,600 sources have registered as of April 2004. DEP expects to have approximately 15,000 sources registered when complete.
- 5. Dave Jostenski showed several maps as examples of GIS information that the Department currently is pulling together as part of the State Water Plan. Included were views of water withdrawals over top of geology and land use, the water quality attainment status and digital elevation models. This information will be posted on the secure Regional Committee page.
- 6. No comments were offered from the public.

Monroe County Conservation District Presentation

Craig Todd, Monroe County Conservation District, discussed water resource management in the area. Mr. Todd's presentation highlighted the new Model Stormwater Ordinance for the Brodhead Creek and McMichaels Creek watersheds in Monroe County. He also provided a handout on their Consumptive Use Tracking report and spoke about Act 167 stormwater management plans and erosion control efforts in the county. Lastly, Mr. Todd emphasized the need for municipalities to be involved in the state water planning effort. Timeline/Flowchart of State Water Plan

Dave Jostenski provided committee members with a timeline of DEP activities that will take place between 2004 and 2008. Sue Weaver reviewed the role of the Regional Committee and included a timeline of target completion dates for Committee tasks. Handouts were provided detailing these activities and tasks.

John Hines reviewed the Act 220 Regional Plan Components (green sheet) and the responsible parties for each component, e.g. state agency, regional committees.
