# **DEP Summary of Activities**

Statewide committee update:

Secretary Hanger adopted the State Water Plan on February 2, 2009. A ceremony was held on March 26, 2009. The Plan and Atlas were distributed to committee members and others who indicated an interest for the Plan. The Statewide Committee met on June 18, 2009. Tim Weston elected to serve as chair of the statewide committee, and David Mandelbaum was elected to serve as vice chair.

Dave Jostenski and Mike Hill provided an update on the development of the new website, which will include a digital atlas. The website is expected to "go live" on approximately 10/21. More information will be sent to committee members as the website is more fully developed.

Jay Braund provided an update on the Water Resource Technical Assistance Center. DEP worked with the TAC subcommittee and SRBC staff to select an entity to "house" the TAC. Pennsylvania Environmental Council was selected through a competitive RFP process. PEC's proposal will include the development of a business model to provide long term sustainability for the center. An advisory board was selected to help guide PEC in the development of the Center.

## **CWPA Nominations**

Dave Jostenski summarized the discussions from the region's technical subcommittee meeting. In addition, Dave described the process for designation of CWPAs, and he gave a virtual tour for the watersheds under consideration for nomination as CWPAs. Dave Jostenski reviewed the criteria for designation as a CWPA, and he reviewed the factors for consideration in developing the nominations. The committee discussed the watersheds and voted unanimously to solicit public comments on the following nominations:

Conestoga River?? – to include Little Conestoga Creek and Mill Creek Swatara Creek – to include Spring Creek, Mill Creek and Elizabeth Run Conewago Creek – to include South Branch Conewago and Little Conewago Creeks
