### DEP Update

John Hines briefly went over the 5/2/05 Update Memo that was distributed to the Committee. He also mentioned that DEP staff met with USGS and Don Bluedorn on April 29, 2005 to evaluate the continued progress on the USGS budgeting tool. As a result of the 4/29 meeting, USGS was requested to attend today's meeting to provide an update (see USGS Budgeting Tool section).

#### **Comments from the Public**

Tim Weston representing the PA Chamber of Business and Industry distributed to the Committee and DEP comments on the draft water use regulations. Mr. Weston noted that during the development of the Act 220 legislation, fee language was deliberately left out of the legislative package and that the Department specifically stated no fees would be imposed on the registration program. Mr. Weston concluded by offering the assistance of the Chamber's technical representatives as a resource to the Statewide Committee and DEP for developing alternate methods to metering for the measurement of water usage.

Mr. Wolff, a member of the Statewide Committee, concurred with Mr. Weston's

statement regarding the fees that the legislation was very specific about not including fees.

Mr. Swartz of the Susquehanna River Basin Commission and a member of the Statewide Committee distributed two handouts to the Committee and visitors. The first was an Op-Ed titled "The Susquehanna: A River Under Stress—But Not The Nation's Most Endangered" and the second was literature regarding the upcoming River Front Symposium on June 8<sup>th</sup>-10<sup>th</sup>.

# **Technical Expert Advisory Pool Discussion**

Mr. Bluedorn explained that the intent of the Technical Expert Advisory Pool was to allow the flexibility to bring experts from various fields in to speak to the Statewide Committee. After a brief discussion, the Committee decided to accept the concept of the Technical Expert Advisory Pool.

# Update from Regional Committee Representatives

There have been no Regional Committee meetings since the last Statewide Committee.

# Subcommittee Activities/Reports

- Public Participation Leslie Sarvis reported on the upcoming May Regional Committee public meetings/hearings.
- P&I David Mandelbaum reported that the Subcommittee conducted a conf. call on 4/28/05 to discuss the CWPA Criteria and Process Documents. After lengthy discussion on the process document, there was reasonable consensus among the Subcommittee members participating on the call that both documents move to the Regional Committees at their May meetings. The Subcommittee discussed its' next tasks of addressing the non-critical and non-technical pieces of the plan and to revisit the vision statement.
- CWPA Jan Bowers reported on the 4/26/05 meeting. Outcomes of the meeting • where: 1.PADEP to revise Criteria and Process documents to incorporate changes and edits discussed and distribute to both P&I and CWPA subcommittees prior to April 28th. 2. CWPA recommends to Statewide Committee that, subsequent to review/changes by P&I subcommittee, the Statewide Committee distribute the revised Criteria Document for review and comment by Regional Committees and that comments be due to PADEP by May 31<sup>st</sup>. 3. CWPA subcommittee requests approval from the Statewide Committee to allow CWPA to work with PADEP to merge the 2 documents into one, and to prepare a nomination form and an accompanying introductory text for the combined document. This final compiled document will incorporate changes from regional committee review comments and will be presented to the Statewide Committee for final approval at their July meeting. 4. PADEP will attempt to review comments and prepare a revised draft in advance of June 14 meeting. 5. Jan will distribute the revised Criteria and Process documents

# **USGS Budgeting Tool**

Curtis Schreffler of USGS gave a PowerPoint presentation on the budget tool that included a demonstration of the capabilities of the tool.

## **Draft Regulations**

Bill Gast presented the revised draft regulations. He mentioned that the Department is in the process of assessing the actual data requirements and depending upon the outcome, there may be reductions on the data requirements currently listed in the draft regulations. The Committee requested DEP to revise the document and send to the Regional Committees with comments due by 6/15/05.

### **Registration Update**

Dave Jostenski updated the committee on the progress of registrations. The Department is targeting Public Water Supply Agencies and golf courses to submit the registration information. Mr. Jostenski also mentioned that the Department is working on a user survey to be distributed later in the year requesting feedback on the registration program.

- 4. Discuss the P&I Subcommittee's thoughts on the non-critical and non-technical pieces of the plan.
