#### **General Advisory Board business**

Two items were discussed.

- The draft meeting minutes from April 18, 2023 TAC Board meeting were presented for discussion. JT Hand
  (NAWC) made a motion to approve the April 18, 2023 minutes as presented. Greg Herb (PAR) seconded the
  motion. The motion passed by a unanimous vote.
- Tentative meeting dates were selected for the 2024 meetings. DEP will confirm the availability of the
  meeting room for these dates. The final meeting dates will be published in the Pennsylvania Bulletin in
  December.

#### **SDW Regulatory Update**

DEP provided a brief update on proposed or newly published final state and federal regulations.

 PA's PFAS MCL Rule was published as a final rulemaking on January 14, 2023. Initial compliance monitoring begins in 2024 or 2025. DEP is offering classroom training sessions – water systems should contact the appropriate regional office for dates and locations.

- The Bipartisan Infrastructure Law (BIL) reauthorizes the base Drinking Water State Revolving Fund (DWSRF) program funding and establishes new supplemental DWSRF pots.
  - The supplemental pots are for general infrastructure projects, emerging contaminants projects, and lead service line replacement projects. DWSRF BIL funding provides funding to eligible water systems via PENNVEST for these infrastructure projects.
  - BIL also provides additional money to states to expand their existing technical assistance programs to help water systems through the existing DWSRF Set-aside program. The funding also covers the cost of administration of the DWSRF program for DEP and PENNVEST staff.
  - o DEP requested and received the maximum allotments for FY 22/23 and FY 23/24.

#### Federal Regulations:

- UCMR 5 monitoring for 29 PFAS and lithium began in 2023 & is ongoing through 2025.
- The proposed PFAS Rule was published March 29, 2023; EPA hopes to publish the final rule by the end of 2023.
- A reminder that the Service Line Inventory required by the Lead & Copper Rule Revisions (LCRR) needs to be completed and submitted to DEP by October 24, 2024. EPA intends to publish the proposed revisions to the LCRR (i.e. the Lead & Copper Rule Improvements or LCRI) this autumn.
- Proposed revisions to the Consumer Confidence Report (CCR) rule were published April 5, 2023. These
  revisions are intended to improve readability, clarity and understandability. EPA intends to publish the
  final CCR revisions in 2024.
- The Microbial/Disinfection Byproducts (M/DBP) Rules are being evaluated for revisions. The National Drinking Water Advisory Council (NDWAC) charged to provide advice and recommendations for these revisions. EPA hopes to publish proposed revisions in 2024.

The TAC Board requested that the LCRR/LCRI update be a standing agenda item.

### **SDW Informational Session**

DEP requested that TAC remind their constituents to routinely check the LCRR website for updated information, including a Q&A guidance on service line inventories. DEP also requested that TAC members remind their constituents on the importance of cybersecurity.

- Water utilities should conduct a Cybersecurity Risk Assessment to identify weaknesses in their information technology (IT) and operational technology (OT) infrastructure. EPA and CISA (the Cybersecurity Infrastructure Security Agency) offer tools and training on cybersecurity topics.
- All cyber-attacks should be reported to the EPA's Water Infrastructure and Cyber Resilience Division (WICRD). The EPA will notify the FBI and the Cybersecurity and Infrastructure Security Agency (CISA), which is part of the Department of Homeland Security, of the attack to ensure a coordinated response.

The TAC Board had the following comments:

- DEP should send an email when there are LCRR updates.
- DEP should clarify the number of excavations needed to verify a service line when water system personnel cannot access a customer's home.

- DEP should clarify what funding may be available for excavations to validate service line data.
- DEP should provide clarification on the definition of a consecutive water system as it relates to manufactured housing communities.

# Draft Proposed Rulemaking - Notification Requirements of Unauthorized Discharges to Waters of the Commonwealth Presentation & Discussion

Manyi Liu, Victor Landis and Drew Hall from the Bureau of Clean Water presented an overview of the draft proposed regulation. The TAC Board had the following comments.

- DEP should clarify what hyperchlorination means. The evaluation should be based upon each situation because the discharge could be normal potable water.
- DEP should clarify whether chlorinated and chloraminated water systems will both be included in the notification requirements.

Tesra Schlupp (PIIA) made a motion that TAC support the Draft Proposed Rulemaking for Notification Requirements of Unauthorized Discharges to Waters of the Commonwealth. The motion was seconded by James Steele (PBA). The motion passed by a unanimous vote.

#### **Public Comments**

- Steve Tarnowski, Environmental Attorney for Merck: The previous directive required every line break and discharge of any quantity to be reported so they support the draft proposed rulemaking.
- Ken Warren, Warren Environmental (Outside Counsel) for Merck commends DEP for moving forward and supports the spill reporting and draft rulemaking and recommends that a revision be added (similar to WQS or MCL) to include a standard numeric value to clarify at what point a spill is substantial enough to need reported.

#### Adjourn

Doug Crawshaw (AWWA) made a motion to adjourn. The motion passed by a unanimous vote, and the meeting adjourned at 11:50 AM.
